Upgrading

Omrah Avenue to Nicklin Way



As part of a major transport infrastructure investment in addressing congestion issues facing Caloundra, Sunshine Coast Council – in partnership with the Queensland Government and the Australian Government – will deliver a new transport corridor, known as the Caloundra Transport Corridor Upgrade, connecting the CBD and Omrah Avenue to Nicklin Way, north of the Caloundra Road roundabout.

This integrated transport corridor upgrade is part of a long-term plan to provide better access to and from Caloundra for public transport users, cyclists, pedestrians and motorists now and into the future. Without this upgrade, travel time, traffic congestion and access for active and public transport in Caloundra will continue to worsen as our community grows.

About the project

The Caloundra Transport Corridor Upgrade (CTCU) is a new transport corridor and a high priority project for improving accessibility, connectivity, safety and travel choice into the Caloundra CBD and surrounding destinations. It is the most significant local transport upgrade project in Caloundra's recent history and will transform access to and from Caloundra for pedestrians, cyclists and motorists.

The 1.6 kilometre corridor, which runs between Omrah Avenue and Nicklin Way, will reduce congestion and improve travel times on existing roads, including at the Caloundra Road / Nicklin Way roundabout, making it easier to travel into and out of Caloundra. This project is also consistent with the community's vision to get people out of cars and adopting more sustainable modes of transport, including walking, cycling, electric vehicles and public transport.

Currently around 100,000 people per day travel through the Caloundra Road / Nicklin Way roundabout. Traffic congestion is often experienced.

The transport upgrade will include a four-lane road with intersection improvements, a new connection at the intersection of Nicklin Way, Third Avenue and Industrial Avenue, a two-way cycle track, pedestrian pathways, new street lighting and landscaping.

Project timeline

The CTCU is a multi-stage project to be delivered over a number of years with a proposed timeline of:

2021	Complete concept design and detailed investigations for Sections 1 and 2
Late-2022	Complete detailed design for Sections 1 and 2
2023 to 2024	Construction of Sections 1 and 2
Late 2024	Completion and opening of the new transport corridor.

More detailed construction timeframes and information will be provided closer to the works commencing.

About the corridor

The new transport corridor is made up of two sections – Section 1 and Section 2.

Section 1 between Omrah Avenue and Arthur Street will include:

- Duplicating existing traffic lanes to provide two lanes in each direction on Oval Avenue and Third Avenue
- Connecting Oval Avenue with Omrah Avenue
- Building a two-way cycle track and pedestrian pathways
- Upgrading the following intersections to traffic signals to improve safety and traffic operations:
 - Bowman Road/Gosling Street
 - First Avenue/Oval Avenue
 - Third Avenue/Oval Avenue
 - Arthur Street/Third Avenue
- Making changes to traffic movements at the following locations:
 - First Avenue, Second Avenue and Third Avenue intersections with Oval Avenue
 - Nicholls Street and Gosling Street intersection
 - Suller Street, Cowan Street and Omrah Avenue intersections with Bowman Road
- · Installing new street lighting and landscaping.

Section 1 of the CTCU will be delivered and funded by Sunshine Coast Council to meet local growth, transport infrastructure and community needs.

Section 2 between Arthur Street and Nicklin Way (referred to as the Nicklin Way/Third Avenue extension) will include:

- Extension of Third Avenue from Arthur Street to Nicklin Way including a two-way cycle track and pedestrian pathway
- Connection of Industrial Avenue to Nicklin Way
- A new signalised intersection on Nicklin Way
- · New street lighting and landscaping.

This section will provide an important new connection to central Caloundra, further improving accessibility, safety and connectivity for the region. Section 2 of the CTCU is jointly funded by Sunshine Coast Council, the Queensland Government and the Australian Government. The Queensland Government Department of Transport and Main Roads (TMR) is working closely with Council to deliver this section.

Caloundra Transport Corridor Upgrade design

The alignment of the corridor has been determined following a lengthy and detailed assessment of planning, environmental, social and engineering considerations.

The CTCU is now focussed on detailed design outcomes for the chosen corridor.

The current concept design has been included in this newsletter and is available to view on Council's website at www.sunshinecoast.qld.gov.au (search for Caloundra Transport Corridor Upgrade).

The community is encouraged to view the design and provide any additional information that may be useful prior to and during upcoming phases of the project, including construction

There is also the opportunity to view the design and meet with the project team at a number of community drop-in sessions.

Project history and community engagement

The CTCU has been subject to numerous transport studies and community engagement processes over the past eight years.

2013

Council completed the Caloundra Area Transport Study in consultation with TMR. This study included community engagement on potential transport options, including upgrading Omrah Avenue to Nicklin Way.

2016

Council's draft Caloundra Centre
Master Plan included the upgrade
of Omrah Avenue to Nicklin Way, as
well as other Caloundra projects.
Community consultation was
undertaken and Council staff met with
key stakeholders to provide notification
of the draft master plan consultation
and submission process.

2018

Council engaged specialist consultants to undertake a detailed analysis of which route would be the most beneficial to Caloundra. Consideration was given to environmental, economic and social opportunities and challenges and the Oval Avenue and Third Avenue alignment was determined to be the best route. Council consulted the community and engaged with key stakeholders on the Sunshine Coast Council Local Government Infrastructure Plan, which included the upgrade of Omrah Avenue to Nicklin Way.

A subsequent proposed planning scheme amendment to reflect the Caloundra Centre Master Plan was also subject to public consultation in 2018.

201

Council and TMR signed the Caloundra Access Memorandum of Understanding which included this project as a jointly delivered contribution to address Caloundra's pressing congestion issues.

2019-2020

Council has continued to liaise with key stakeholders, including adjacent landowners and businesses along the CTCU corridor. In 2020 Council revised the CTCU design based on feedback from these stakeholders.

Keeping you informed

Council has been liaising with directly impacted property and business owners during the planning and development phase and will continue to do so throughout the project.
