Airports

- 1 Charges apply to aircraft parked in non-leased areas only. Charges apply per 24 hours or part thereof.

 Aircraft for sale or maintenance. Applies to aircraft parked in general parking areas 1st month free if Airport is advised prior to parking. Sale or maintenance dispensation is available fo maximum of one month per aircraft.
- Advance Purchase Discounts. Non-transferrable and for the time period specified or part thereof. All payments must be received in advance to be eligible for Advance Payment Discount. Aircraft parked contrary to prepaid charges, will be charged the daily rate. Maintenance Concession is available on pre paid three month advance purchase discounts.
- 3 This is a general airport user charge that includes parking in non-leased areas.

2 Reserve a grave. NB: If site not renewed, reservation will be cancelled and site reallocated

Commercial Activities on Community Land

- 1 No discount applies to permit fees where the permitted use in full time, access to council controlled land is daily and permitted operating hours include 6am to 7pm or 7am to 7pm.
- A 50% discount applies to permit fees, where the permitted use is part time, access to council controlled land is limited (not an all-day operation) and equipment is removed from council-controlled land following each lesson, or activity.
- 3 A 25% discount applieto permit fees, where the same permit holder is awarded more than one (1) permit, and the permits are awarded for the same type of activity.
- 4 Payment options include: Annual payment, 30 days following date of invoice; or Quarterly payments, with scheduled due dates; or Monthy payments, with scheduled due dates. Direct debit is available for all above payment options. Pro-rata fees will be available for permits issued throughout the permit period (1 July 2013 to 30 June 2016)

Community & Performance Venues

Community Response

0 Refunds - Refund assessment criteria

Application fees/Licence/Registration/Permit/Approval fees - refund only where the service was not started*.

*Definition of "started" means checking application details in the corporate systems, commencing review of the application/plans/submission, undertaking any historical review/file revie organising for field services including booking vehicles and equipment, organising monitoring/support of any kind, and any similar activities undertaken by Council in the provision of services.

Service fee and Inspection fees - refunds may be approved dependant on services provided or for costs to cancel the service. Alternatively the refund amount may be credited to the applicant to be utilised at a later date for the same service. Early notification by the applicant may provide for more favourable refund.

Refund due to error

Refund only where a fee has been charged in error by Council or where an applicant has paid more fees than are required (overpayment or double payment) via consideration of documentation. A change of mind by the applicant is not an error.

Refund due to extenuating circumstances

Council may refund fees due to extenuating circumstances if the applicant can provide sufficient documentation for consideration.

- 1 ATO Registered Deductible Gift Recipient discount 50% if you meet ATO criteria or as set by council policy
- 1 Pro-rata fees apply for new applications lodged during the year.
- 5 Environmentally Relevant Activity Reduced Annual fee must meet eligibility criteria under s.126 of the Environmental Protection Regulation 2008 50% of the annual fee if—
 - (i) the holder is an approved partner; and
 - (ii) the holder has an approved EMS; and
 - (iii) the holder has a lower emissions score.
- 6 Environmentally Relevant Activity Reduced Annual fee must meet eligibility criteria under s.126 of the Environmental Protection Regulation 2008 60% of the annual fee if—
 - (i) the holder has an approved EMS; and
 - (ii) the holder has a lower emissions score.
- 7 Environmentally Relevant Activity Reduced Annual fee must meet eligibility criteria under s.126 of the Environmental Protection Regulation 2008 70% of the annual fee if the holde an approved partner and—
 - (i) the holder has an approved EMS; or
 - (ii) the holder has a lower emissions score
- 8 Environmentally Relevant Activity Reduced Annual fee must meet eligibility criteria under s.126 of the Environmental Protection Regulation 2008 80% of the annual fee if— (i) the holder has an approved EMS; or (ii) the holder has a lower emissions score.
- 9 Environmentally Relevant Activity Reduced Annual fee must meet eligibility criteria under s.126 of the Environmental Protection Regulation 2008 90% of the annual fee if the holde is an approved partner.
- Multiple food preparation areas Supermarket with deli, bakery, butcher Resort with kitchen, kiosk, bar, café/bar Restaurant/Hotel/Function/Reception Centre with multiple kitchen or service areas aged care facility or hospital with kitchen and multiple service areas. All food preparation areas must be at the same location and operated by the same licencee.

- 11 Manufacturer Includes packaging, peeling, canning, bottling, combining ingredients this does not refer to food being made at a premises for sale at/from the premises or vehicle.
- 12 Manufacturer of high risk foods includes manufacturer of infant food, infant formula.
- 13 Manufacturer of medium risk foods Manufacturer of bottled water, cakes/desserts, chocolate and cocoa products, milk, butter, cheese, yogurt, eggs and egg products, fruit juices, canned/processed/frozen fruit and vegetables, ice cream, canned meats, meat/vegetable pies, nuts and nut products, prepares/packaged meals, salads, sauces, canned/processed seafood, soya products.
- Manufacturer of low risk foods Manufacturer of biscuits, brewery, confectionary, condiments, cordials/syrups, cereals, oils, pastry, pickles, chips, pretzels, muesli bars, soft drinks, tea/coffee, vinegar, honey.
- 15 Child care centre Includes long day care, occasional day care and employer sponsored day care (does not include family day care).
- 16 Off site caterer Means serving potentially hazardous food at a place other than the principle place of business for the food business.
- 17 A food business which provides chairs and tables for its patrons. Includes café, restaurant, bar and aged care facility with dining room only.
- 18 Takeaway food bar Chairs and tables are not provided for patrons by the food business. It is generally expected the food will be "taken away" for consumption soon thereafter. Fast food, kiosk, canteen, business in a food court.
- 19 Bakery This category covers bakery/café and bakery/takeaway food style premises.
- 20 Retail food shop Unpackaged foods requiring minimal food preparation for retail sale. Convenience stores, petrol stations, fruit and veg shop, ice cream only shop, deli slicing cold meats/cheese, sale of bread & bakery items. If the business has chair
- 21 Retail food vehicle This refers to vehicles used in connection with a fixed food business where the food is prepared and packaged at the fixed premises and the vehicle acts as a retail outlet ie, lunch vans.
- A food business that provides meals with accommodation, including a bed and breakfast and farm stay. If meals are provided to patrons other than guests of the accommodation the premises must be categorised as an eating establishment.
- 23 Food vehicle, Food van, food caravan or food boat If the food business is conducted from a vehicle, a van, caravan or boat which includes food preparation, it is a mobile food business.
- 24 Water carrier Sells/carries potable water for drinking.
- 25 Annual temporary food premises includes regular market stalls or tents. May operate at more than one market or event.
- 26 Event temporary food premises 1 off long event a maximum of 12 days A tent, stall, cart etc at a special event. For example, food festivals, music festivals, sporting events.
- Applies to food business licences that have expired. The payment of the restoration fee and renewal fee within 30 days of the expiry of the licence enables the licence to be renewed instead of cancelled.
- 28 Pro rata fees apply for a new licence application (this does not include licence renewals). 1 September 30 November = Full fee, 1 December 28 February = 3/4 of full fee, 1 March 31 May = 1/2 of full fee, 1 June 31 August = 1/4 of full fee.

29 Event temporary food premises - 1 off short event - a maximum of 4 days - A tent, stall, cart etc at a special event. For example, food festivals, music festivals, sporting events.

Holiday Parks

- 1 Charges apply from 29 January 2013 to 27 January 2014 (unless otherwise stated)
- 2 All charges for occupancy are based on up to two persons per site All charges are GST inclusive All cabin prices include linen.
- 3 GST applies to all occupancies between 1 and 27 days at the rate of 10% and thereafter at 0% as per division 40 of the GST legislation.
- 4 Long term permanent sites at Dicky Beach pay for electricity consumption costs.
- 5 Peak Season Easter Holidays (29 March 2013 to 14 April 2013) and Christmas Holidays (14 December 2013 to 27 January 2014). Noosa River also includes the June School Holida (22 Jun-7 July 2013) and September School Holidays (21 September-7 October 2013) in its peak season.
- 6 Shoulder Season 22 June 2013 to 7 October 2013. Boreen Point Camp Ground, Noosa North Shore Camp Ground and All Cabins include the September School Holidays only as the shoulder period.
- 7 Off Season All Other Periods.

Legal Services

1 Where the complexity of an item warrants a Charge greater than that provided, an hourly rate can be applied. Hourly rate is to be applied for all work associated with actions under Par 1 Chapter 4 of the Local Government Act 2009 (Overdue Rates)Hourly rate to be applied in preparation of any other agreement contract, deed etc where not otherwise provided.

Multisports

- 1 Full day = a maximum of 10 hours, Half day = maximum of 4 hours.
- 2 Commercial or private user: Events/activities are undertaken for profit. Includes those events not being staged for profit but may possess commercial features such as promotional activities, giveaways or advertising. Private functions and celebrations such as weddings, party etc
- 3 Community user: Aimed at general community, not for profit in nature. Where it is claimed the event is a "fund raiser" providing evidence can be given at time of booking that 100% of funds raised at the event are being donated to a registered charity or a charitable cause then the community rate may be applied. Government organisations, including internal council teams are charged the community rate.
- 4 School user: State or independent primary, secondary or tertiary educational institution
- 5 Tenured user: Holds a lease or a licence (issued by Community Leasing) to occupy sports fields/car track at Landsborough Sports Complex
- 6 Maroochydore Multisports Complex car park hire: Carpark 1 not available for hire any day. Carpark 2 not available for hire Sunday available all other times other than when sports fields are in use.

- 7 A security bond will be required at the time of booking. The amount will vary in accordance with the size and type of event.
- 8
 Field Hire charges includes change rooms and adjoining car park.
- 9
 For all Netball court hire at Maroochydore Multi Sports complex refer to Sunshine Coast Netball Association phone 5451 0416.
- 10 Private celebrations such as weddings, parties and the like are not permitted at Maroochydore Multi Sports and Meridan Fields Sporting Complex.

Operating a Business or Not for Profit Organisation

- 1 Pro-rata fees apply for new applications lodged during the year.
- 2 Annual Beach Access Permits: surf clubs, police, fisheries and emergency services are not charged a fee.
- 3 Scheduled payment plans are available on request.

Response Services

1 Farmers/primary producers conducting roadside stalls adjacent to their property are exempt from the fees. An application is required in order for the site to be assessed for safety purposes.

Use of Public Space and Council Land

- Applicant is the organisation, company or individual taking responsibility for management of the permitted activity and must be the holder of the public liability insurance for the permitte activity.
- This fee is conditional upon an assessment of the activity meeting one of the following criteria: 1) promoting the region as a tourist or visitor destination; or 2) enabling a local business market it's product or services; or 3) developing a local industry segment; or 4) marketing or promoting a major or regional event.

Waste Management

- 1 Approval must be obtained for disposal of Regulated Waste before disposal. Charges will be determined by Council as part of the approval process.
- For all loads of material that were initially accepted and charged as clean Construction and Demolition Waste and subsequently suspected of being contaminated (e.g. asbestos), no refund will be applicable to the customer who chooses to remove the load from site.
- 3 Green Waste vegetation waste arising from maintenance of parks, gardens, and land, and not mixed with other types of waste. Excludes processed timber and wood, putrescible wastes such as fruit and vegetable produce and trunks of trees and plants with a diameter greater than 30cm.
- 4 Nambour Landfill Dead Animals Large 24 hrs notice required prior to disposal.

- Weighed transactions occur and disposal is charged on a unit rate per weight, when a vehicle and/or attachment load is in excess of 500kgs. If a load of waste upon arrival is estimated be in excess of 500kgs, but as a result of the weighing process found to be less, disposal charges shall be calculated using the schematic schedule. Additional individual items charges also apply for nominated waste types e.g. tyres.
- To be applied to cyclic type services (e.g. 8 or 12 weekly) and for when a resident requires an extra service outside of and in addition to their scheduled frequency. Charge is for up to ε including 5000 litres per service. Excess litres (> 5000 litres) will be charged at the extra litres rate.
- 7 Volume transactions only (i.e. charging on volumetric quantity rather than weight) occur at sites without a weighbridge, or if a weighbridge is unserviceable at the time of transaction. Additional individual items charges also apply for nominated waste types e.g. tyres.
- 8 Weighed transaction occurs to commercial loads over 500kg. All other loads are to be treated as per the schematic for the relevant vehicle size transporting the material.
- 9 Disposal charges under the schematic schedule i.e. small medium & large are a guide only and not intended to cover every possible vehicle configuration. The description of quantity is the basis for charging not the pictorials of vehicle configuration. Additional individual items charges also apply for nominated waste types e.g. tyres.
