Sippy Downs Parks Master Plan Review

Summary Report

Introduction

The Draft Parks Master Plan and an online questionnaire were distributed to all residents, property owners and body corporates at Sippy Downs for review to identify issues and priorities for consideration in the Sippy Downs Parks Master Plan.

Community input received through the review and the online survey provided feedback on park planning and master plan concepts. The feedback and priorities will be carried through to ensure future planning addresses the concerns and needs of Sippy Downs park users.

Purpose

The purpose of gathering community feedback on the draft plan is to ensure that the final plan provides activities and future infrastructure that respond to community needs.

The responses and data from the online survey are intended to identify the priorities for future park development, upgrades and asset renewal across the park network.

Questionnaire

The questionnaire was used to gather targeted data for analysis of the community's views and priorities for future park uses, activities and development. The questionnaire was designed to give participants the opportunity to rank their preferences for park features and priorities for the future. Data from the online survey and feedback provides Council with a clear indication of the elements that are valued more than others.

Feedback and Analysis

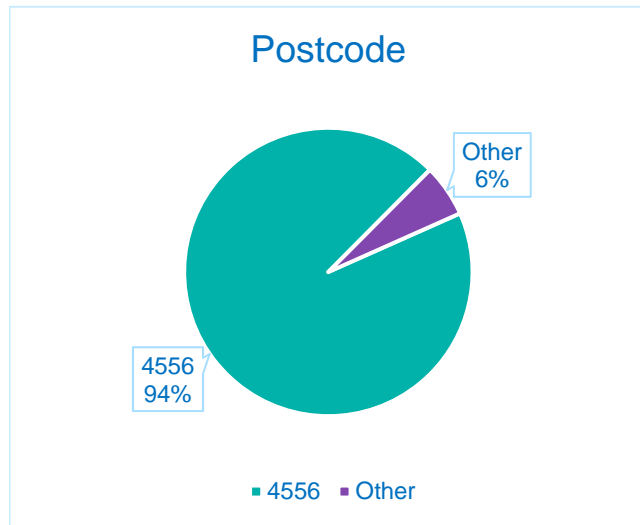
Throughout the period of the consultation between 26 February and 26 March 2018 there were a total of 152 respondents to the online survey, and 51 written submissions received from 34 community stakeholders.

During the consultation the draft plan and opportunity for the community to provide feedback was promoted extensively across traditional and social media. The Facebook advertising post was seen 48,803 times, reached 7,416 people, and prompted 639 views of the web page.

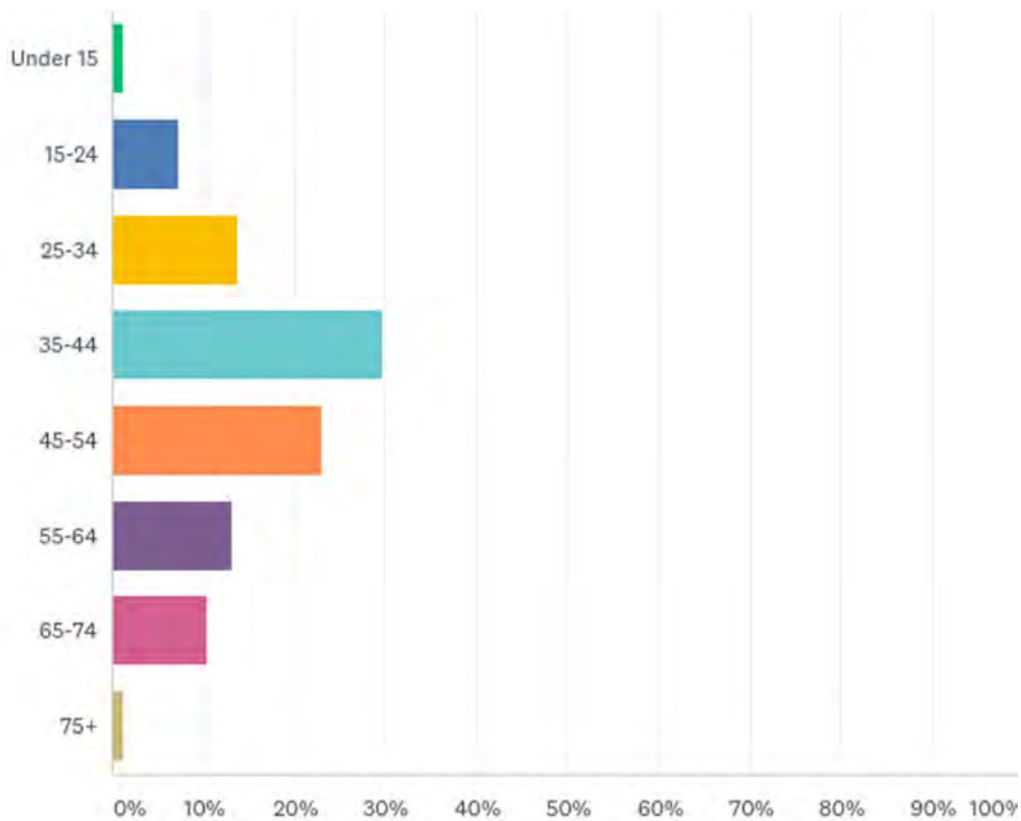

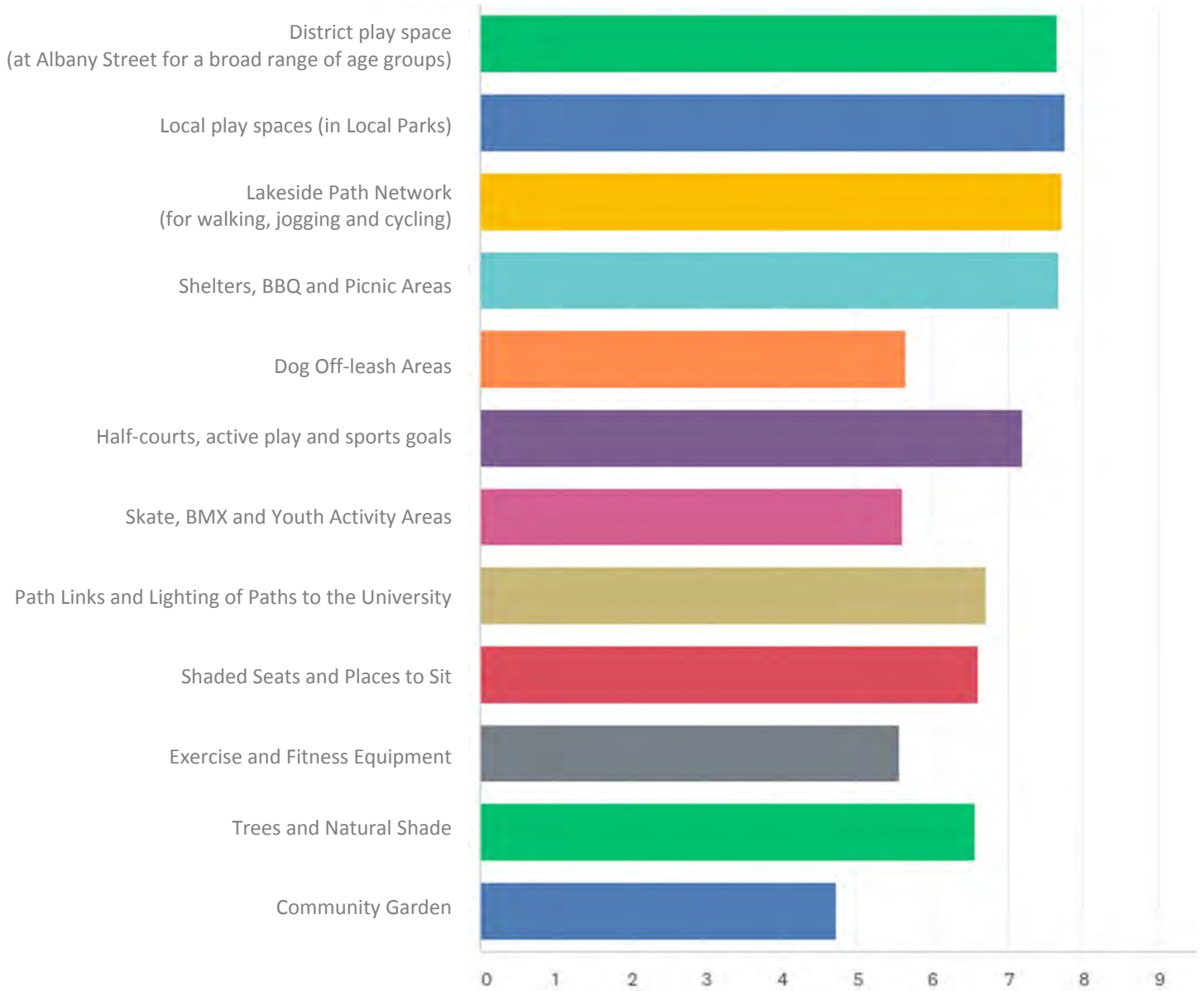
Question 3: Are you male or female?

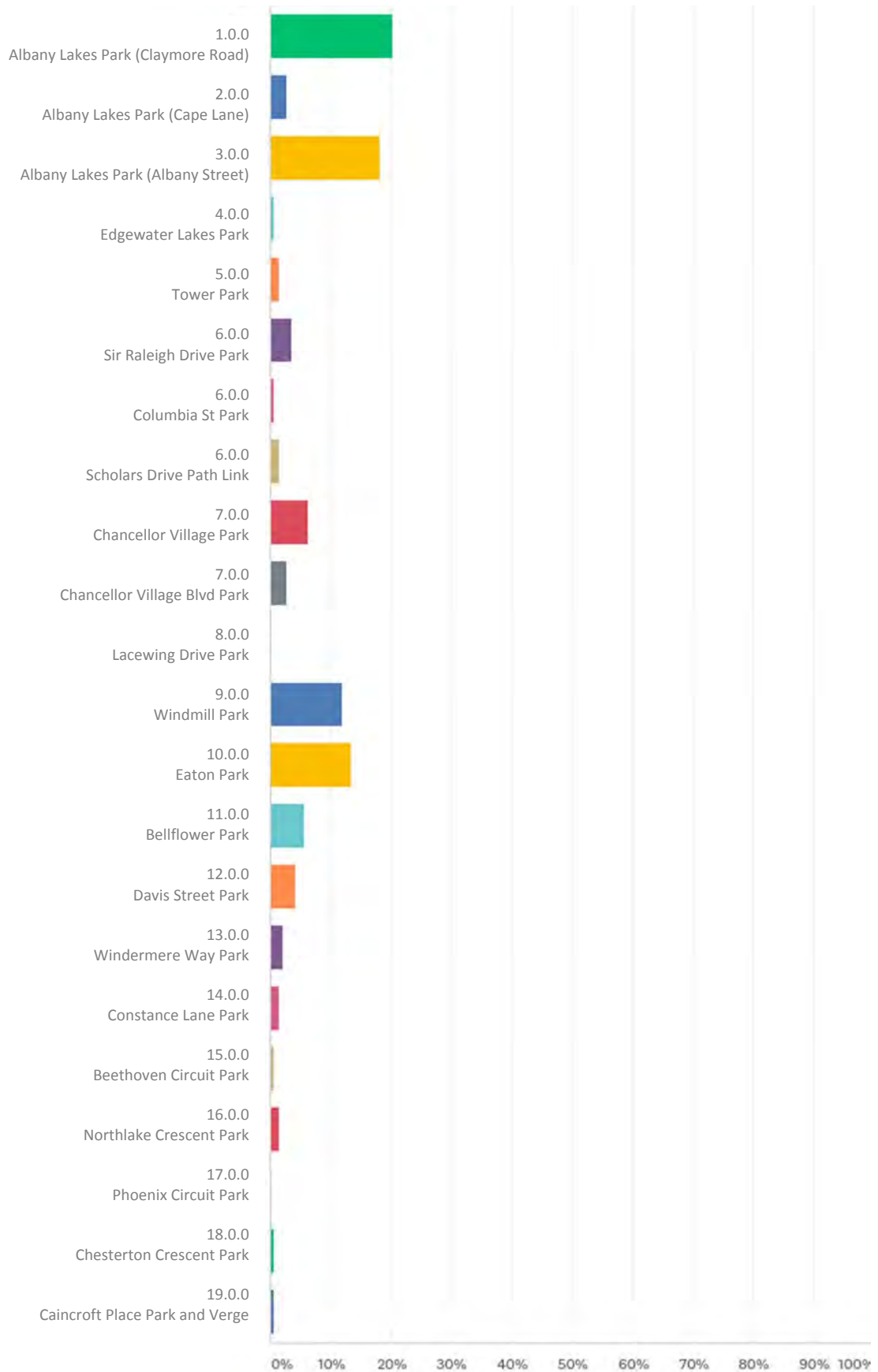
Question 4: Would you visit the parks at Sippy Downs more or less often if the Parks Master Plan was implemented?

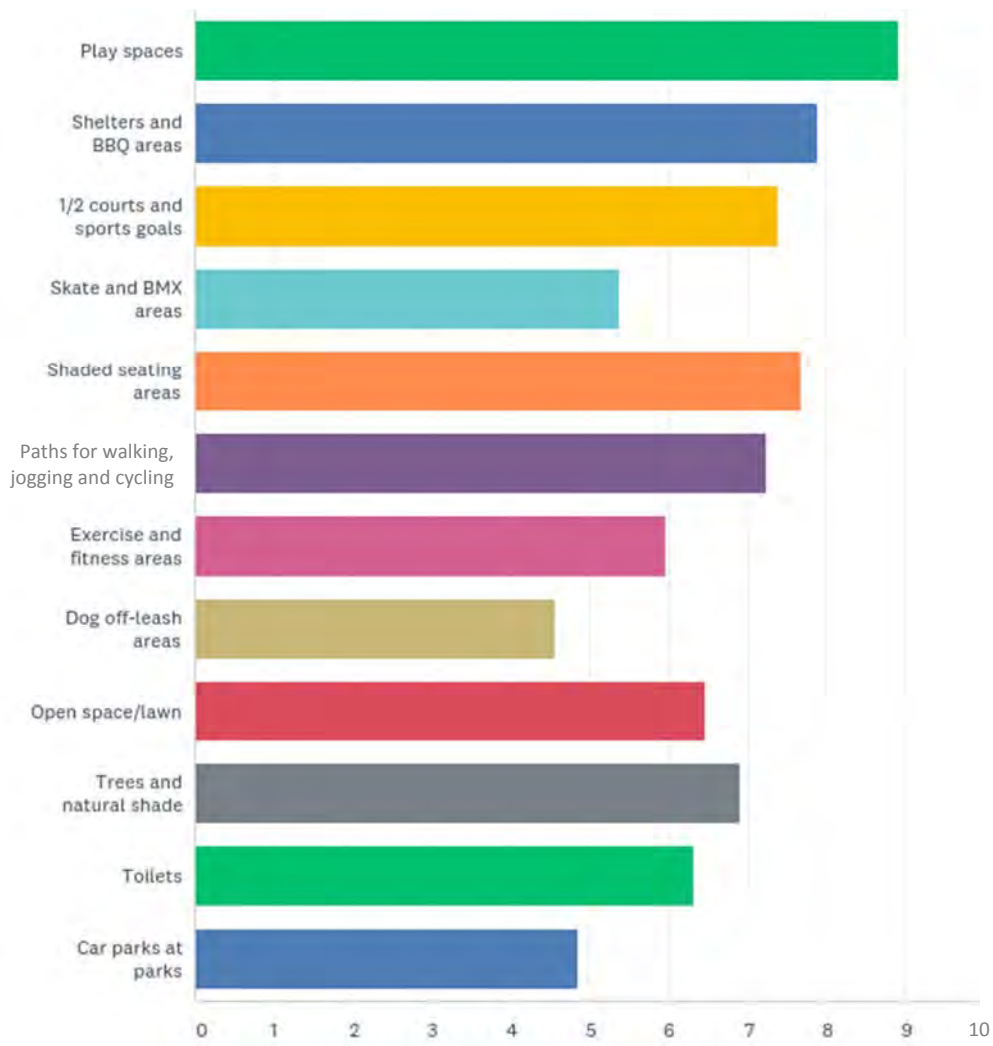


Question 6: Of the 19 parks listed in the Draft Sippy Downs Park Master Plan which one would you most like to see prioritised?

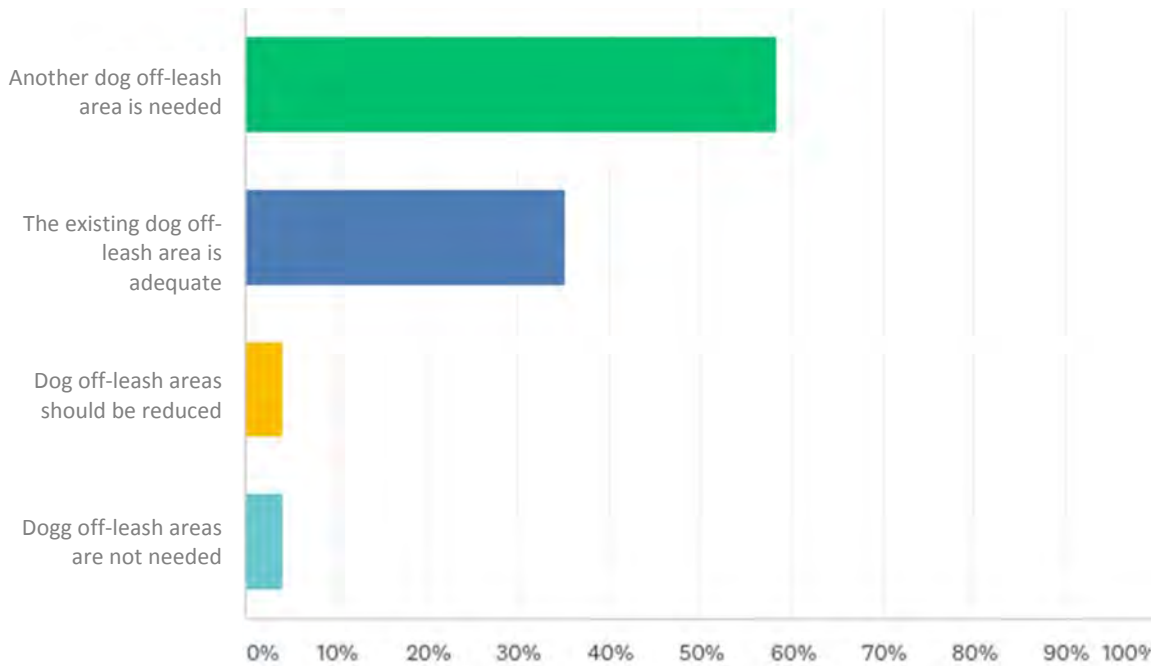

Draft Sippy Downs Parks Master Plan

Project summary

The draft Sippy Downs Parks Master Plan has been prepared to guide the development and management of parks and open space at Sippy Downs. The draft plan identifies opportunities and priorities for future upgrades and asset renewal based on a review of existing infrastructure, activities and community feedback.

Funding has been allocated by Councillor Dickson to deliver the outcomes of the plan for the Sippy Downs parks network. The plan also provides the basis to seek further funding for development and renewal of park infrastructure at Sippy Downs.

Implementation of the full scope of the plan will be dependent on funding and will be staged over the next 10 - 15 years.

Master plan development

In October 2016 the community was invited to undertake a park user survey and provide feedback to help shape the future of the park network. The survey provided useful feedback on park use, key issues and demand for park activities.

This feedback has been used to guide the development of the draft master plan which aims to:

- identify a range of actions and initiatives to be delivered by council
- reflect the community's vision and priorities for the future of the park network.
