Sunshine Coast Council, in partnership with the Department of Transport and Main Roads (TMR), is pleased to provide an update on the Caloundra Transport Corridor Upgrade (CTCU) project. This significant infrastructure initiative aims to enhance connectivity, reduce congestion and support the future growth of Caloundra. The CTCU will connect Caloundra's business centre and Omrah Avenue to Nicklin Way via a 1.6 kilometre-long active transport and road corridor. Project update

This month, TMR and Sunshine Coast Council finalised design for the CTCU with a call for construction tenders expected in the coming weeks.

The project team has spent the last year optimising the design after announcing the confirmed corridor footprint that was informed by our community and Stakeholder Interest Group.

We understand the importance our greenspace plays within our community and we have worked hard to refine the corridor width where possible to avoid impacts.

It is anticipated that Council will receive Environment Protection and Biodiversity Conservation (EPBC) Act approvals and start construction of this important upgrade in late 2025.

The final design reflects community input and balances infrastructure development needs with environmental preservation, liveability and sustainability.

Construction timeline

Major works are expected to start late 2025, following the receipt of the remaining environmental approvals and the appointment of a construction contractor.

Detailed construction time frames and information will be provided closer to starting works.
