PUBLIC NOTICE SUNSHINE COAST REGIONAL COUNCIL SUNSHINE COAST PLANNING SCHEME 2014 (MAJOR AMENDMENT) NO. 19 CALOUNDRA CENTRE MASTER PLAN

Notice is given that, on 9 September 2019, Sunshine Coast Regional Council adopted the Sunshine Coast Planning Scheme 2014 (Major Amendment) No. 19 - Caloundra Centre Master Plan.

The purpose and general effect of the amendment is to reflect the adopted Caloundra Centre Master Plan and respond to a small number of other matters related to development in the Caloundra Centre, including amendments to:

- the zoning, the Height of buildings and structures overlay, the precincts and the assessment benchmarks for the Caloundra Local Plan Area:
- the tables of assessment for development in the Caloundra Local Plan Area and generally for development on Council owned or controlled land in the Community facilities zone; and
- the Transport and parking code figures to reflect proposed new road and public transport routes in Caloundra.

The amendment will commence on and from 23 September 2019.
