

# **Community Grants Program** *Guidelines*

(Updated June 2025 Version 1.5)

The Community Grants Program supports and enables community organisations to deliver projects that contribute to our shared goal of a strong Sunshine Coast community. We value the resources and skills that community organisations and their volunteers bring. Council invests in projects that address community needs and align with our <u>Community Strategy 2019-2041</u>, along with other regional priorities and our commitment to sustainability within the Sunshine Coast Biosphere.

Council welcomes applications that contribute to making a strong community in the following areas:

- *Healthy, active communities* Information, services, and programs to support physical and mental health and wellbeing.
- Vibrant communities Community places and spaces, transport and housing are available for all.
- Inclusive communities Opportunities for everyone to participate and be involved.
- *Connected, resilient communities* Communities are connected, resilient and safe. People work together to achieve shared goals.
- Creative, innovative communities People value creativity, heritage, and First Nations culture.

#### Assessment criteria

Major and Minor Grant applications are assessed using the intent, purpose and priorities of the chosen category as well as the following criteria:

- · demonstrated need for the project, activity or event
- · benefit to the people of the Sunshine Coast Local Government Area
- evidence of consultation, community partnerships and collaboration
- strength of alignment with community priorities as described in current Council strategies, plans or policies
- capacity of the applicant to successfully complete the project
- · balanced, realistic and complete project budget
- level of funding contributed by the applicant and/or others towards the project
- evidence the organisation has inclusive participation policies and practices
- · evidence the organisation is working towards or maintaining self-sufficiency
- show alignment with the Sunshine Coast Biosphere's values (participation, celebrating belonging and innovation).

Further consideration will be given to projects that:

- · reduce environmental impact and/or deliver sustainable living outcomes
- · build skills, capacity and governance of community groups
- activate places and spaces
- procure from local businesses, social enterprises and/or First Nations businesses
- budget to procure a Welcome to Country by the Traditional Custodians of the Sunshine Coast (the Kabi Kabi peoples or Jinibara peoples).

Lower priority is given to applicants who have been awarded a council Major or Minor grant within the previous 12 months.

#### **Category priorities**

Projects funded under this category will address one or more of the following:

- · improve physical and mental health and wellbeing
- · activate community places and spaces
- respond to and support people experiencing homelessness
- contribute to community members feeling valued, respected, welcome and included
- support and recognise volunteers and promote volunteering opportunities
- · encourage community participation and involvement
- strengthen social connections and sense of belonging, and reduce social isolation
- prepare for, respond and recover from climate risks, disasters and emergencies and enhance community resilience
- · improve community safety and feelings of safety
- · work towards preventing domestic and family violence
- support our Sunshine Coast Biosphere by promoting sustainable living and travel practices and behaviours
- build the skills and capabilities of community organisations to help achieve these priorities

In relation to applications for animal management grants, projects must:

- enhance community safety outcomes
- align with the key objectives of Council's Management Plan for Domestic Animals (Cats and Dogs) 2021 -2030
- assist in the promotion and advancement of responsible pet ownership practices eg desexing, microchipping, registration.

Community Facilities Category Outcome: Vibrant Communities

This category supports projects that develop, maintain or improve buildings or land, ensuring safe, accessible and inclusive community facilities.

Choose this category if your project involves planning or undertaking work on buildings or land. Examples include but are not limited to:

- facility improvements (such as extensions, renovations, accessibility ramps, amenities)
- facility repairs and maintenance (such as painting, guttering, window replacement)
- permanent installations (such as solar panels, air conditioning, signage)
- new infrastructure (such as sheds, shade, fences)
- land improvements (such as drainage, irrigation, landscaping
- · costs associated with planning of projects for permanent works.

#### **Category priorities**

Projects must meet all of the following outcomes:

- provide well maintained and inclusive community facilities that enable opportunities for community connection
- adhere to the principles of access, equity and inclusion
- help manage identified risks
- comply with Australian Standards
- minimise environmental impact Reuse, Reduce, Recycle and follow the seven principles of sustainable construction: sustainable design, durability, energy efficiency, waste reduction, indoor air quality, water conservation, sustainable building materials
- have a current maintenance schedule.

Well-developed projects that are ready to be delivered and have secured co-funding (if required), are highly regarded. See co-funding section above for details.

#### **Festive and Commemorative Events Grants**

Festive and Commemorative Events Grants support costs associated with delivering the following community-led event types **only**:

- Festive Season Events\* Christmas, New Year (31 December / 1 January) and Australia Day
- Commemorative Events Anzac Day and Remembrance Day

Applications for funding for **all** other types of events can be submitted in the Major or Minor Grant rounds under the category most relevant to the focus of the event. Please contact a Grants Officer on (07) 5420 8616 for assistance with selecting the most appropriate category for your event.

#### Festive and Commemorative Events Grants (Cont.)

Multi-YearWell-established community organisations with a proven track record of delivering festive or<br/>commemorative community-led events that meet above priorities can apply for up to three<br/>years funding.

All the following criteria must be met:

- evidence of collaboration with council regarding the event
- evidence applicant group is well-established
- strong history of applicant group successfully delivering the event
- evidence of long-term planning and commitment to deliver event for funding term.

Where multi-year funding is allocated, subsequent years of funding will be conditional upon:

- delivering agreed outcomes
- compliance with funding conditions
- satisfactory acquittal of previous year's funding
- Council's budget availability.

Applicants interested in applying for multi-year funding must contact a Grants Officer on 5420 8616 before submitting an application.

#### **Emergency Grants**

Emergency grants are available to support projects that have arisen as a consequence of failure, damage or loss of essential equipment or infrastructure due to unforeseen circumstances. During a declared Disaster Situation, applicants can apply for other costs (including, but not limited to, operational costs when an organisation demonstrates financial hardship).

Eligibility	Eligibility criteria for Emergency grants are the same as Major and Minor grants.
Funding Amounts	Applicants can apply for up to \$3000.
Projects Eligible for Funding	<ul> <li>Funding must be for projects or costs which are:</li> <li>deemed to be an 'emergency' (requiring rapid response)</li> <li>significantly impacting the organisation's ability to continue to operate.</li> <li>Costs may be incurred prior to application, but applicants should be aware that funding is competitive, and council cannot guarantee that the application will be successful.</li> <li>Costs that are covered by insurance are not eligible for Emergency Grant funding.</li> <li>Only one Emergency Grant related to a declared Disaster Situation can be made by an organisation per disaster event, per financial year.</li> <li>*A declared Disaster Situation is one where a Notice of Declaration of Disaster Situation has been published in the Queensland Government Gazette, and affects the Sunshine Coast Local Government Area.</li> </ul>
Assessment Criteria	<ul> <li>Emergency grant applications will be assessed using the following criteria:</li> <li>failure, damage or loss of essential equipment or infrastructure due to unforeseen circumstances and deemed to be an emergency</li> <li>significant impact on the organisation's ability to continue to operate</li> <li>significant health and safety implications for the organisation's and/or service users</li> <li>evidence that the project is not covered by insurance.</li> </ul> During a <i>Declared Disaster Situation</i> the following assessment criteria can apply, subject to available budget: <ul> <li>significant impact on the organisation's ability to continue to operate, due to:</li> <li>costs that have arisen due to a declared disaster event, or</li> <li>cash flow hardship as a result of a declared disaster event.</li> <li>costs meet the significant community need created by the declared disaster.</li> <li>priority will be given to applications which evidence an organisation's financial hardship and/or a plan for sourcing more sustainable funding into the future.</li></ul>

### **Individual Development Grants**

Individual Development Grants are available to support Sunshine Coast Local Government Area residents who are performing, competing or presenting at national or international competitions, conferences or events (eg sport, arts, cultural, community, heritage, economic and environment).

Individuals must be selected by a recognised national body and provide a letter of selection. Eligibility and Assessment Criteria Individuals who meet all of the following criteria: have been a permanent resident in the Sunshine Coast Local Government Area for at least the preceding 12 months are representing the region by performing, competing or presenting at national or international competitions, conferences or events have met acquittal conditions for previous council funding. In addition to the above, applicants for sporting events must be: competing in official national and international championships, recognised by a National Sporting Organisation (NSO) that is endorsed by the Australian Sports Commission selected for an official Queensland or Australian team, endorsed by the relevant National Sporting Organisation (NSO). For non-sporting applications: the assessment panel will confirm the status of the selecting body individuals are eligible to receive funding for one national and one international competition, conference or event per calendar year only. Activities that have already begun prior to a grant application being submitted are not eligible for Individual Development Grant funding. While this program offers a maximum of \$500 per individual, there is a sliding scale of Funding Limits funding amounts relating to the nature of the activity, its location, and (where relevant) the number of individuals from a team applying. (see table below) Groups or teams attending the same event: The total amount of funding to members of a group or team attending the same event cannot exceed \$2,000. Any team member who wishes to apply, must submit their own application. Team applications will not be accepted, however all eligible members of the same team who wish to apply MUST submit their applications within the same assessment period. Funding will assist with expenses incurred whilst attending an activity eg travel, accommodation, entry fee and registration.

## **Information for Grant Applicants**

Lodging an Application	Application forms are submitted online via Council's grants and funding webpage <u>www.sunshinecoast.qld.gov.au/grants</u> . These forms will be made available on council's website when the relevant round is open.
	Quotes are required for all items over \$500 and must be included with your application.
	The delivery of the Community Grants Program is subject to annual budget allocations.
Assessment	Grants are assessed by panels, which include council staff experienced in each category.
	In some instances, part-funding may be offered.
Payment	Successful applicants will be notified via email and will be directed to fill in the online Funding Agreement Form before payment can be made.
	Funds must be claimed within eight weeks of notification, except where an extension has been granted.
	In some instances, there may be specific Conditions of Funding that need to be met before payment can be made.
	If the applicant is being auspiced, payment will be made to the auspicing organisation.
Acknowledgement	All successful applicants are required to acknowledge council's support actively and publicly. The level of acknowledgement required is outlined in the funding program agreement and associated acknowledgement guidelines. Council's logo and Acknowledgement Guidelines will be emailed to successful applicants following notification.
	In addition, funding recipients must also ensure that council's positive reputation is maintained at all times.
Acquittal	Acquittal is the process where you show how you spent allocated funds. All successful applicants must submit an online acquittal within eight weeks of project completion. Organisations will not be considered for further grant funding from council if previous grant acquittal conditions have not been met. Please note that you will be required to return funds if you do not submit a satisfactory acquittal that includes proof of expenditure.
