Role

The Board member must have a well-developed understanding of the arts and creative sector, the political environment at all levels of government and must be able to proactively contribute to achieving the Board's objectives in a professional and independent manner.

The member will act as part of a cohesive team that provides strategic advice to Council and advocates for the arts and creative sector on the Sunshine Coast.

The member may be required to represent the Board at events and functions.

Responsibilities

The Board member is responsible for applying strategic business experience and knowledge to contribute to the Board's objectives to:

- a) Proactively build the identity of the Sunshine Coast as destination/location for arts and creative businesses, tourism and industry.
- b) Advocate the region's advantages to secure new investment in arts and cultural infrastructure.
- c) Provide strategic advice to Council in relation to arts and cultural facilities, infrastructure and funding opportunities.
- d) Provide advice on strategic direction as it applies to cultural policy and strategy.
- e) Provide advice and identify opportunities for the Sunshine Coast arts and cultural sector in the lead up to, specifically as it relates to the cultural Olympiad and Cultural Legacy, during and after the 2032 Brisbane Olympic and Paralympic Games.
- f) Provide opportunities to develop philanthropic activity in relation to the regional arts offer, including maintaining positive ongoing relationships with the Sunshine Coast Arts Foundation

Experience

The member must have:

- a) Extensive experience as an arts/creative sector business/entrepreneurial leader with well-developed networks and relationships.
- b) Deep understanding and knowledge of the Queensland political/business/commercial landscape (State and regional levels) as it applies to the arts and creative sectors

- c) Well-developed team skills to ensure open, collaborative, confident and constructive communications and discussions with a board populated by highly experienced and professional members from diverse arts backgrounds.
- d) Well-developed political acumen.
- e) Experience in advocacy/relationship management would be advantageous.
- f) Demonstrated experience as a Board/committee member, including knowledge of Board processes and governance.

Personal attributes

- Integrity- acting ethically and within a local government governance framework. Having appropriate independence, putting the sector's interests before personal interests.
- Collaborative Ability to work cooperatively and respectfully to reach consensus on key issues
- Effective communicator the ability to engage and effectively communicate with all stakeholders.
