Sunshine Coast Council Public Space Lighting Master Plan Considerations
 March 2015

The following locations are suggested for consideration by CiteLum Australia in the development of the Public Space Lighting Master Plan for the Sunshine Coast Council area. These locations and associated general information provided are based upon anecdotal information provided by local police only. Safety audits or CPTED reviews have not been undertaken upon these locations. Proposed lighting treatments for these locations should incorporate CPTED principles.

Suburb	Location	Issue	Comments/Suggested treatment
Alexandra Headland	Alexandra Headland Skate Park, Alexandra Parade	Popular night time use by young people. Ongoing issues with anti-social behaviour, property damage and alleged drug activity	Lighting should be reviewed to ensure suitability for intended night time use.
Maroochydore	Council car park, Duporth Avenue	Secluded car park at the rear of commercial buildings in old CBD. Poor lighting.	Due to recent development in the old CBD including night time entertainment this car park has seen increased use.
	Transit Centre, Horton Parade	High volume of pedestrian use. Previously required police attention due to undesirable loitering and anti-social behaviour.	Review lighting to ensure suitability
	Ocean Street, Maroochydore	Recent redevelopment to create a night time entertainment precinct. Now subject to high volume night time use with numerous licensed premises nearby.	Lighting requires review to ensure it is adequate given the changed use of the area.
Mooloolaba	River Esplanade and Foote Street	Used as a thoroughfare (particularly by night club patrons) between Wharf complex and Mooloolaba Junction Shopping centre (McDonalds). Public order and property damage issues. Designated Safe Night Out Precinct (SNP)	Consider improved lighting
	Brisbane Road Council car park	Lighting currently sufficient but review would be required if CCTV were to be installed in the future	No treatment suggested
	Mooloolaba Esplanade precinct	Vegetation encroaching upon existing lighting causing shadowing in some areas – needs review	Review lighting with consideration given to vegetation maintenance and control
	Mooloolaba Beach, Beachfront park and main beach area	Current flood lighting of beach area is excellent.	Please consult police further if any changes are to be made to existing lighting.
	Mooloolaba Boardwalk and pathway, Between	Boardwalk lighting needs to be reviewed due to seclusion of area and	Review existing lighting

Beerwah	Beerwah Library, Peachester Road	Inadequate lighting. Popular congregation spot due to seclusion caused by vegetation. Undesirable loitering, anti-social behaviour, property damage and alleged drug activity	Consider improved lighting
	Beerwah Community Hall, Turner Street	Undesirable loitering, anti-social behaviour, property damage and alleged drug activity	Consider improved lighting
	Turner Park in the vicinity of Skate Park, Turner Street	Undesirable loitering, anti-social behaviour, property damage and alleged drug activity	Consider improved lighting
Coolum	Jack Morgan Park, behind Coolum CBD, Elizabeth Street	Inadequate lighting	Consider improved lighting
	Tickle Park, associated skate park and beach front area, David Low Way, Coolum	Inadequate lighting	Consider improved lighting
	Mt Coolum car park, Cnr Tanah St West and Jarnahill Dr, Mt Coolum	Inadequate lighting. Increasingly popular tourist location both day and night	Consider improved lighting
Mudjimba	Skate Park, Mudjimba Esplanade and associated public toilets	Inadequate lighting.	Consider improved lighting
Nambour	Nambour Skate Park, Matthew & Ann Sts	Inadequate lighting. Popular congregation spot for young people.	Consider improved and timed lighting
	Currie St & Mill Lane intersection	Inadequate lighting. Significant pedestrian use at night time. Vicinity includes Railway Stn, McDonalds Restaurant, nearby licensed premises and ATMs	Consider improved lighting
	Roundabout ins. Mill Street & Mill Lane	Inadequate lighting. Adjacent to Coles Supermarket, Council car	Consider improved lighting

Palmwoods	Palmwoods Skate Park and adjoining car park, Palmwoods-Montville Road	No lighting. Congregation area for young people at night despite lack of lighting. Previous property damage including Graffiti and alleged drug activity.	Consider improved and timed lighting
Sippy Downs	Varsityview Court, Sippy Downs	Lack of lighting in Bus stop area where University students wait for buses at night	Consider improved lighting
