Sunshine Coast Planning Scheme 2014 (Major Amendment – Palmview Structure Plan, Palmview Structure Plan Planning Scheme Policy and Consequential Amendments) No. [to be inserted]



1. Short title

This amendment instrument may be cited as *Sunshine Coast Planning Scheme 2014 (Major Amendment) No.* [to be inserted].

2. Commencement

This amendment instrument has effect on and from [to be inserted].

3. Purpose

The purpose of this amendment instrument is to amend the following components of the *Sunshine Coast Planning Scheme* 2014:

- (a) the Palmview Structure Plan including the Palmview Structure Plan Maps, to:
 - (i) reflect revised land use locations, densities and road layouts;
 - (ii) remove references to the "Greenlink" (north-south and east-west public and active transport) corridors;
 - (iii) to ensure the capacity of infrastructure in residential areas surrounding non-residential uses such as schools is adequate;
 - (iv) remove provisions relating to the Housing Affordability Fund agreement which has now lapsed;
 - (v) relocate and rename the former "Local Industry and Enterprise Area" to the "Local Employment Area";
 - (vi) amend the ecological protection and rehabilitation target from 615 hectares to 483.4 hectares which removes the requirement to provide land external to the Palmview Structure Plan Area but protects all the land within the Palmview Structure Plan Area that is protected under the current Structure Plan;
 - (vii) remove the specific target of 12.5% of housing to be affordable, but retain the requirement for affordable housing to be provided;
 - (viii) increase the GFA for the District Activity Centre from 12,000m² to 15,000m² commensurate with the removal of the two of the four Local Activity Centres;
 - (ix) remove the requirement for vertical integration of residential and non-residential uses in the District Activity Centre;
 - (x) achieve consistency with the requirements of the *Sunshine Coast Planning Scheme 2014* for roads, public transport, bicycle, pedestrian and open space infrastructure;
 - (xi) remove the water and sewerage infrastructure requirements in accordance with Unitywater's direction;
 - (xii) amend the energy infrastructure network provisions in accordance with the electricity infrastructure entity's requirements;
 - (xiii) remove telecommunications infrastructure requirements as they are addressed through the provisions of the *Sunshine Coast Planning Scheme 2014;*
 - (xiv) protect operations of existing lawful uses from being compromised by the encroachment of sensitive land uses; and
 - (xv) implement mapping amendments to reflect the above changes;
- (b) the Palmview Structure Plan Planning Scheme Policy, to:
 - (i) reflect changes made to the Palmview Structure Plan and standards of provision for infrastructure to ensure consistency with the *Sunshine Coast Planning Scheme 2014*;

- (ii) remove the water and sewer desired standards of service in accordance with Unitywater's requirements;
- (iii) remove the requirements for the preparation of the Energy Management Plan, Sustainable Transport Plan and Affordable Living Plan in accordance with changes to the Palmview Structure Plan; and
- (c) other planning scheme provisions including maps, to make any consequential planning scheme amendments to reflect changes made to the Palmview Structure Plan and Palmview Structure Plan Planning Scheme Policy.

4. Amendment tables
