#### Attachment 2 Amendment Instrument

#### 1. Short title

This amendment instrument may be cited as Sunshine Coast Planning Scheme 2014 (Alignment Amendment) No. 9.

#### 2. Commencement

This amendment instrument has effect on and from the day fixed by proclamation for the commencement of the *Planning Act 2016* under section 2 (Commencement) of the *Planning Act 2016* 

#### 3. Purpose

In accordance with the Alignment Amendment Rules (Minister's rules under section 293 of the *Planning Act 2016*), the purpose of this amendment instrument is to:

- (a) improve and clarify assessment benchmarks, notably codes, to ensure they are sufficiently robust to permit assessment as required by the decision rules for code assessment under the *Planning Act 2016*, and taking into account the matters referred to in section 43(2) of the *Planning Act 2016*;
- reformat or revise the structure of the planning scheme to improve its clarity or operation, including but not limited to removing or altering certain sections of a QPP – compliant planning scheme which may be redundant;
- (c) replace terminology or language from repealed or soon-to-be-repealed legislation (e.g. the Sustainable Planning Act 2009) with terminology consistent with the Planning Act 2016, including but not limited to names of categories of development or categories of assessment and content for the regulated requirements in the Planning Regulation 2017; and
- (d) implement changes of form not involving substantial changes of substance.

### 4. Amendment table

This amendment instrument amends the component of the *Sunshine Coast Planning Scheme* 2014 in Table 1, Column 1, in respect of the planning scheme provisions stated in Table 1, Column 2, in the manner stated in Table 1, Column 3.
