The Open Space Strategy identifies that there is a deficiency of local parks to the east of the rail line and this shortfall is being addressed through land purchase and local park development.  The Open Space Strategy has not identified the need for a District Level Park in Cooroy, or proposed the increasing of Apex Park from a local to district level park.  Council officers have identified that some park and playground assets at Apex Park require upgrading.
