## 3. Background

Council manages approximately 7500ha of land within the environmental reserve network and approximately 80 lakes and constructed wetlands. Maintenance of these Natural areas includes weed control and revegetation works and is managed via internal staff through a contract delivery model.

Maintenance functions include bushland regeneration, weed control, and revegetation in council managed environmental reserve network and edges of lakes and wetlands. The contract will consist of 9 separable portions including 8 contract zones plus a separable portion for specialist rope access weed control operations to service rocky headlands and steep slopes.

What are the objectives of this contract?

To provide professional Natural Area regeneration services across the Environmental Reserve network, including Councils constructed lakes and wetlands systems

How will objectives be achieved?

Council officers assess each site and provide annual work instructions to the contractor for site works.

How will achievement of objectives be measured?

Council will audit all contractors following completion of works and/or as contractor performance reviews on a 6 monthly basis.

What are the alternative ways of achieving the objectives? Include reasons for not adopting alternative ways.

Council may choose to expand on the internal service delivery teams.

## 6. Market and Risk Assessment

There are many known service providers locally and across South East Queensland which have provided competitive submissions for previous tenders. Incumbent contractors are considered local suppliers with established local presence. Procurement risks identified

- 1. Service requirements can fluctuate seasonally through prolonged wet or dry periods. This can directly impact on a Contractor's ability to deliver the required outcomes for the contract, while operating a sustainable business (staff retention considerations, knowledge and skills lost).
- 2. Contract Structure and ability to balance the needs the organisation and project outcomes whilest retaining a number of skilled contractors.

#### Proposed mitigations for identified risks:

- 1. This is a schedule of rates contract that can provide flexibility in delivery. Contract activities can be adjusted to suit prolonged wet or dry weather conditions.
- 2. Contract will be in multiple separable portions, and anticipate awarding no more than 2 zones to each contractor (subject to outcome of evaluation). This will allow for multiple local contractors to provide service to Council, as well as acting as a contingency for instances of such as performance issues with another contractor.

- 1. Environmental and Legislative Risks including management of biosecurity risks and herbicide application. Council officers conduct regular audits to ensure compliance with legislation, labels and permits. Council also requires a Herbicide log as part of the contractor report for every work visit and site
- 2. Workplace health and safety is considered an ongoing risk which is mitigated through legislative requirements which the contractor is required to adhere to. Council officers conduct regular contractor audits and the contractor is required to attend Contract performance meetings.
