

#### **About this Action Plan**

The draft Community Safety Action Plan 2016 - 2020 enables implementation of the intent of the *Sunshine Coast Social Strategy 2015* and relevant policies pertaining to community safety. It builds upon council's commitment for "A Strong Community – Supporting an engaged, resilient and inclusive community that embraces diversity".

### What is a safe community?

A safe community is one in which all sectors of the community work together in a coordinated and collaborative way, forming partnerships to promote safety, manage risks, increase safety and reduce the fear of harm. The key feature is the creation of local networks (i.e. coalition of community, business and government leaders) that combine resources and interests to address local concerns about community safety and crime prevention in a coordinated and sustainable manner.

The *definition of community safety* that applies to this action plan is:

Community safety refers to actual and perceived safety concerns and risks of harm and injury that may affect the community's quality of life and wellbeing. The primary focus is on reducing the risk and fear of crime through the design and management of places, as well as through the development of a strong sense of community. Community safety is a shared responsibility—achieved—by—working—in partnership with other levels of government and non-government organisations and the community.

This Action Plan focuses on social conditions and risk factors that facilitate crime and measures that attempt to reduce the opportunities for crime related activity in the physical environment. They include:

- Strong community and partnerships
- Crime Prevention Through Environmental Design (CPTED) and Closed Circuit Television (CCTV)
- Alcohol, drugs and anti-social behaviour
- Graffiti management<sup>1.</sup>

The other areas of safety that do not fall within this action plan are:

- Road safety
- Beach safety
- · Emergency Disaster and Management
- Local Laws
- Planning

Community safety is addressed through a number of existing Council's policies, strategies and plans, local laws and state and federal legislation as outlined in Appendix 1.

# Why do we need a Community Safety Action Plan?

While judicial and law enforcement roles are the jurisdiction of federal and state government, local government is an active facilitator of collaboration at the local level between federal, state and community organisations on issues of community safety.

This Action Plan details how council intends to enhance safety and perceptions of safety, to assist in the prevention of crime and to coordinate actions to increase actual and perceived safety in public spaces.

The Action Plan identifies council priorities in community safety and directs efforts for building partnerships with key organisations, groups and individuals. It is also provides for a multi-disciplinary approach across council to address safety issues that may impact upon our community.

The Action Plan is an on the ground response to council's strategic policy position. It is designed to be used by council's Community Safety Officer in delivering improved community safety outcomes for the region.

## 1 Strategic alignment of this Action Plan

The Community Safety Action Plan is aligned with the intent of council's *Corporate Plan 2014-2020*, *Social Strategy 2015* and *Community Safety Policy 2014*. The actions within this Community Safety Action Plan implement the intent of these key strategic documents.

# 1.1 Sunshine Coast Corporate Plan

The Sunshine Coast Corporate Plan 2014-2020 identifies the attainment of "A strong community – Supporting an engaged, resilient and inclusive community that embraces diversity". Four outcomes have been identified in the corporate plan in relation to this goal:

- · Safe and healthy communities
- · Resilient and engaged communities
- Culture, heritage and diversity are valued and embraced
- · People and places are connected

# 1.2 Sunshine Coast Social Strategy 2015

Council's Social Strategy identifies a number of aims that respond to the corporate goal of "A strong community" and the associated outcomes. They include

- · Retain high perceptions and levels of safety
- Partner with key stakeholders and state agencies to develop effective and appropriate local responses to underlying social issues
- Consult with the community on important matters
- Ensure the provision of community infrastructure contributes and responds to community needs.

# 1.3 Sunshine Coast Community Safety Policy

The Sunshine Coast Community Safety Policy 2014 states that "Community Safety is a shared responsibility of all levels of government and the community. Council acknowledges that each level of government has a different role to play in building safe communities. Greater community safety outcomes can be achieved through working together with people and organisations from multiple sectors taking joint responsibility and pooling resources."

The policy has five guiding principles which have been incorporated into the Community Safety Action Plan. These are:

- · Evidence-based decision making
- Strengthening community and partnerships
- Integrated and coordinated proactive approach
- · Compliance with relevant legislation
- Monitoring and evaluation

Other components of safety which help to shape the scope and focus of this Action Plan are:

- Strong community and partnerships formed to address community safety issues and build the capacity of our community and partners.
- Crime Prevention Through Environmental Design (CPTED) and Closed Circuit Television (CCTV) contribute to the design of public spaces that reduce the opportunities for crime.
- Alcohol, drugs and anti-social behaviour strategies that aim to reduce harms associated with alcohol and drug abuse and associated behaviours.
- Graffiti management that promotes the rapid response to the removal of graffiti improving public perceptions of safety.

# 2 Council's role in Community Safety

A benchmark review of local government organisations in Queensland illustrates that most councils adopt a diverse approach to community safety and with specific actions that respond to local priorities.

# 2.1 What does Council currently do?

Council already has a well-established platform of existing policies, strategies and plans which contribute to community safety.

The Sunshine Coast Council Community Safety Policy 2014 and the Sunshine Coast Council Public Space Closed Circuit Television (CCTV) Policy 2014 contribute to the integration of Crime Prevention through Environmental Design (CPTED) principles in our built environments and the management of CCTV systems, graffiti and anti-social behaviour. Addressing anti-social behaviour is a community issue which depends on strong partnerships with State government, local business and community organisations.

Some examples of council's current activities and partnerships include:

- CPTED site assessments for organisations to define aspects of the built and natural environment which influence safety.
- The delivery of graffiti management initiatives in partnership with community and the Queensland Police Service.
- Participation in Community Safety committees established on the Sunshine Coast region. These committees comprise of various local organisations including progress and community associations, Chambers of Commerce, the Queensland Police Service, local Neighbourhood Watch and other agencies relevant to the local community.

#### 2.2 The role of Council

Council's role in community safety is integrated with other levels of government.

The lead agency for crime prevention is the Queensland Police Service.

Council plays an important leadership role in facilitating and establishing collaborative approaches and actions to community safety.

Council is a key player in helping to facilitate multi-stakeholder involvement in community safety. It achieves this through the following roles:

#### Leader

Lead by example, community messaging on important matters

#### **Partner**

Contribute funds and/or resources towards an initiative or service that is delivered with or by other parties

#### Facilitator/Initiator

Bring together stakeholders to collectively pursue a shared interest or service or to resolve an issue

#### Owner / Custodian

Manage community assets including buildings, facilities, public space and reserves

#### Service Provider

Fully fund a service or provide a service, e.g. retrieval of CCTV footage

#### Information provider

Develop resources to promote a common understanding; provide information; distribute and display community information provided by others

#### Advocate

Make representation or seek to influence the outcome on behalf of the community

#### Regulator

Specific role in response to legislation which may be direct, specific or general in nature

#### 3 Community Safety Implementation Framework

### Community Safety Philosophy Statement:

Draft Community Safety Action Plan 2016-2020

Community Safety is a shared responsibility of all levels of government and the community. Council acknowledges that each level of government has a different role to play in building safe communities. Greater community safety outcomes can be achieved through working together with people and organisations from multiple sectors taking joint responsibility and pooling resources to make communities safer.

#### **Guiding Principles:**

The following five principles will guide the application of the Community Safety Action Plan:

- Evidence-based decision making: Council's safety initiatives are supported by evidence to ensure that the strategies and actions adopted make the best use of available resources and are appropriate to the region's safety needs and priorities.
- Strengthening community and partnerships: Community safety initiatives are focused on building and strengthening the capacity and resilience of Sunshine Coast communities. This region is a community of communities each with their own considerations, strengths and differences. Council values its key stakeholders and community's input to the development of safety initiatives and planning relevant to stakeholder's needs and capacities.
- Integrated and coordinated proactive approach: Community safety initiatives proactively respond, as part of an integrated, collaborative and problem solving approach to future and current issues of community safety.
- Compliance with relevant legislation: Council will actively seek to coordinate the requirements of all levels of government.
- Monitoring and evaluation: Council will monitor and evaluate initiatives to ensure early detection and management of arising safety issues, and to ensure desired outcomes of initiatives are achieved.

#### **Priority Areas**

The Community Safety Action Plan will focus the delivery of actions through three priority areas:

- Stronger, resilient and safer communities through partnerships: Stronger, resilient and safer communities will be achieved through working together with people and organisations from multiple sectors taking joint responsibility and pooling resources.
- Strong community safety messaging: Council will provide leadership through strong messaging on community safety to raise awareness of issues, brings people and organisations together and facilitate community based initiatives that can respond to local needs.
- Great spaces and places: Council will create and maintain great public spaces and places where people feel safe and everyone can enjoy.

### 5 Monitoring and review

- Improved funding alignment and opportunities for community safety initiatives
- Design policy is set for the development of the private realm and where development impacts on adjoining public space
- Memorandums of Understanding are in place with relevant agencies
- Established "Hospitality Precincts" for entertainment purposes
- · Enhanced management of CCTV systems
- CPTED principles are integrated within new master planned communities
- CPTED principles are integrated within Council's master planning and landscape design works
- Coordination of timely graffiti removal requests
- Maintenance and linkage to a regional graffiti database shared with law enforcement agencies.
