### Part 1 Preliminary

#### 1 Short title

This subordinate local law may be cited as Subordinate Local Law No. 7 (Airport) 2017.

#### 2 Commencement

This subordinate local law commences on 1 October 2017.

#### 3 Purpose and how it is to be achieved

- (1) The purpose of this subordinate local law is to supplement *Local Law No. 7 (Sunshine Coast Airport) 2017* in order to provide for the safe, secure and orderly operation of the Sunshine Coast Airport.
- (2) The purpose is to be achieved by providing for—
  - (a) the declaration of airport land; and
  - (b) the declaration of an airport corporation for specified airport land.

#### 4 Authorising local law

The making of the provisions in this subordinate local law is authorised by *Local Law No. 7 (Sunshine Coast Airport) 2017* (the *authorising local law*).

#### 5 Definitions

Particular words used in this subordinate local law have the same meaning as provided for in—

- (a) schedule 1 (Dictionary) of Local Law No. 1 (Administration) 2011; and
- (b) the authorising local law.

# Part 2 Airport land and airport corporation

#### 6 Airport land—Authorising local law, s 6(1)

- (1) For section 6(1) of the authorising local law, the following land is declared to be airport land—
  - (a) from the commencement of this local law—the land that has the property description mentioned in part 1 of schedule 1, as indicated by the hatched area on the map in part 2 of schedule 1; and

- (b) from the airport land extension date—
  - (i) the land mentioned in paragraph (a); and
  - (ii) the land that has the property description mentioned in part 1 of schedule 2, as indicated by the hatched area on the map in part 2 of schedule 2.
- (2) In this section—

airport land extension date means the date on which the local government's lease of the land mentioned in subsection (1)(b)(ii) expires.

- (3) The local government will notify the public of the airport land extension date by—
  - (a) publishing a notice in a newspaper circulating in the local government area at least 2 weeks before the airport land extension date; and
  - (b) publishing a notice on the local government's website.

### 7 Airport corporation—Authorising local law, s 7

For section 7 of the authorising local law, the following entity is declared to be the airport corporation for the airport land declared in section 6—

• Sunshine Coast Airport Pty Ltd as trustee for Sunshine Coast Airport Trust


# Part 2 Map of airport land at commencement date
