 - (1) advocates for the recognition and protection of the regional inter-urban break separating the Sunshine Coast from the greater metropolitan Brisbane area
 - (2) advocates for the removal of the Caloundra South Halls Creek Identified Growth Area (IGA) on the basis that this area is not suitable for urban development and intrudes into the regional inter-urban break
 - (3) advocates for the retention of the Beerwah Caloundra South Corridor Identified Growth Area (IGA) on the basis that this area is potentially suitable for urban development, is well located relative to transport and infrastructure networks and does not intrude into the regional inter-urban break
 - (4) advocates for Maroochydore to be retained and reinforced as the Principal Regional Activity Centre for the Sunshine Coast
 - (5) advocates for the needs of the aviation industry on the Sunshine Coast including the Sunshine Coast Airport, Caloundra Aerodrome and the establishment of an appropriately scoped and located new satellite training facility south of Caloundra and
 - (6) appropriately reflects and incorporates the other directions of council as provided at the special meeting
 - (ii) forward the preliminary submission referred to in (i) above to the Department of State Development, Infrastructure and Planning
- (b) advocate the positions in the submission in (a) above through the South East Queensland Council of Mayors, Local Government Association of Queensland, through direct discussions with the Minister for State Development, Infrastructure and Planning and through other relevant consultation forums with the state government and

note that a separate submission will be made on the draft South East Queensland (c) Regional Plan 2014-2041 once it is on public exhibition.
