Learn to Surf Lessons and Elite Surf Coaching, with the number of students per instructor not to exceed eight (8) at any one time and all equipment to be removed from council-controlled land, including car parks, following each lesson		Mooloolaba Beach, including the spit beach is very popular and home of the Mooloolaba Surf Life Saving Club with restaurants, cafes and takeaway food outlets nearby. The beach is protected from southerly winds and is a popular location for families with children. The beach is excellent for swimming and is generally calmer than other locations. The beach and surrounding parks are popular for wedding ceremonies, major events and other community events throughout the year.

Economic Development Branch	The proposal will allow the operator to utilise the calmer areas for learn to surf lessons and utilise the area closer to the Spit in strong surf conditions. The extended area will now go across a designated flagged bathing area that runs 7 days per week all year round at Mooloolaba Spit. The designated bathing area is typically beachside of Urunga Esplanade but can move relative to the day's ocean conditions. The permit will need to include conditions prohibiting the activity within the flagged bathing area and coordinate with the duty lifeguard each day. Environmental Operations Branch	Reviewed the documents and cannot see any issue with the proposed extension of activity area from BA 182 to 194 for the applicant Learn to Surf Lessons however the permit will need to include conditions prohibiting the activity during renourishing works in the area and coordinate with the Environmental Operations Branch to determine suitable area for business to operate during the renourishment period.
