<b>Property Summary</b>	<p>Lake Kawana is a man made non-tidal flow lake that was constructed as a focal point of a major mixed use development precinct in Kawana Waters. It comprises a 72.37 hectare lake that provides a 2,000 metre championship rowing facility and extensive infrastructure for community use. The lake is intended for the use of the community and for specific non-motorised aquatic events subject to the permitted uses and constraints of the Management Plan.</p> <p>Lake Kawana is the focus of several developed and developing precincts such as Kawana Aquatic Centre/Stockland Stadium Sporting Precinct, Eastbank, Kawana Business Village, proposed Town Centre, apartment buildings to the south of Kawana Business Village with lake frontage and residential/multi residential development throughout the Birtinya Island and The Decks localities.</p> <p>Due to the community focus of the lake and conditions of the original Development Approval, there are several limitations and restrictions applicable to use of the lake by residents.</p> <p>The use of jet skis or motorised boats for private use is strictly prohibited and as a result, a resident does not have the same level of amenity in Lake Kawana as experienced in the nearby Parrearra Lake Reserve where motorised boats are permitted and boat owners can obtain estuary and ocean access via a loch and weir system.</p> <p>This factor has been taken into account when assessing an equitable annual rental structure for any new leases for approved marine structures.</p>

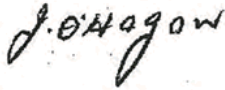
