Thanks for your response. Please check the request below and advise of your agreement that it is consistent with TAMP applications.

Following on from previous discussions, I have itemised below areas where the integration of TAMPS and LGIP is applicable for Sunshine Coast Council. I ask that you review these points, change or add as you see fit and provide back to me as an agreed position on the integration process:-

- TAMPS are either complete or well advanced across all of Council's infrastructure networks, enabling appropriate services to be provided to our community. A focus of these TAMPS is to recognise the age, condition and suitability of infrastructure sufficient to inform a capital works Renewals programme.
- There are equivalent TAMPS covering the LGIP networks of Stormwater (quality and conveyance), Transport (road and active), and Parks & Open Space embellishments. (It is noted that TAMPs do not yet incorporate Land.)
- The network planning supporting the LGIP provides for growth infrastructure, complementing the whole-of-life cycle asset planning identified in the TAMPS.
- Council, in determining its ten year capital works programme, gives due consideration to meeting its statutory and community obligations informed by Council's LGIP works schedule and the TAMPS Renewals works schedule.
