



# Chair's report

This report covers the fourth year, 2022 to 2023, of the Sunshine Coast Arts Foundation, and is marked by two important changes in administration and our philanthropic strategy.

In terms of administration, SCAF's inaugural Administration Officer, Celestine Doyle, who was responsible for the development and delivery of our guiding policies and plans, retired, facilitating reflection on a new administrative structure to take SCAF to the next stage of development. We have now appointed an Administration Assistant and a Development Officer. Both have backgrounds as artists and in development roles with Sydney based arts companies, before moving to the Sunshine Coast. Andrea Briody and Tobias Merz have provided experience, ideas and strong communication skills to support the board as we increase our quest for donors and a region-wide culture of philanthropy.

The second change was the establishment of 'Patronage Philanthropy' into our Gifted Annual Campaign. Donors of \$1000 select an art form which is matched to the artist whose expression of interest is of the highest quality in this art form. Such patronage brings the pleasure and experience of knowing the artist, sharing the journey and 'the value of this art and this artist in the minds of those who watch and hear'. Patronage Philanthropy is very different from a government grant, because the patron donor realises a personal ambition of investing in the sustainability of the artist and the prosperity of the arts. Three such patrons have already increased their donations.

The following feedback from Gifted artists and their patrons illustrates this:

What a delightful young woman. I'm so pleased she's been gifted some assistance. She seems worthy and pleasantly confident, while also new to the big wide world of art as an income...

I feel so positive to be helping her in this small way. Congratulations on your choice. (Patron)

Being a recipient of the Gifted Program not only provided physical means to create a body of work and was foundational in building my confidence to become a practising and exhibiting fine artist. Since exhibiting Gold Beneath I've experienced continued momentum with many unexpected opportunities and highlights. A sincere thank you for creating the program that does an exceptional job of championing creatives on the coast. (Artist)

This is amazing news, such a huge support in *my arts practice and a huge boost to my* developing metal sculptures, as a young artist. I look forward to meeting like minded individuals and thanking Ferre for the support towards my future. (Artist)

The Annual Campaign raised \$6000 and, utilising other donations, gifted nine artists each \$1000. During the year, SCAF also realised four Partnerships with donations through SCAF totalling \$46,322. One donor has steadfastly made donations to artists and/or arts organisations in contemporary dance. The outcome is a strengthened dance community across the region, supporting new works, dancers, choreography, innovative staging and increased audiences for this artform.

We continue productive partnerships with the Regional Gallery in Caloundra and the University of the Sunshine Coast. In March we co-presented an 'Advocacy' event at the Gallery as a forecast for the construction of the new Gallery. And a group of USC students as part of a Work Integrated Learning program, created a wonderful short video of artists in the Sunshine Coast which has become an important promotional communication tool.

In addition, with support from Spicers and their Maleny restaurant Tamarind in August 2022, we hosted an event for business, tourism and arts leaders, designed to encourage partnerships creating a new arts identity for the Sunshine Coast.

The philanthropic income total donations of \$46,000 may not be as much as SCAF would wish, but the responses demonstrate increased awareness by artists and arts organisations and spaces across the region, building networks, reputation, promotion and resources. We must be patient in acquiring capital and develop the power of looking ahead.

Several factors drive SCAF's performance, just as they drive the culture of giving good governance, a philanthropic approach to service, and a motivating and wellresourced strategic plan. Our vision and mission exemplify our relationship with donors, the Council, partners, artists, arts organisations and the entire Sunshine Coast community. Success is not only measured in \$ and positive social media posts. Success is measured in trust, the stories by artists and donors, by partnerships, and the board's collective approach to decision-making. Through trust, honesty and the practice of our values, we also demonstrate value for Council's support through the Arts Levy, not because we have an ambition for operational sustainability, but because all partnerships, all shared strategies, all achievements and success, represent the Sunshine Coast's overarching vision.

The end of this financial year indicates a strong base for future development and I thank the board, our donors and our staff for their invaluable support of SCAF. While philanthropy is increasing in the region, it is yet to realise major donations from high wealth donors and businesses. The strength of the Sunshine Coast region are the shared values of community, prosperity, trust, independence and quality. Our task is to position SCAF as the leader in investment that transforms the region through the arts.

# Finance committee report 22/23

The 2022/23 year continued to see the growth of the Foundation and also the Sunshine Coast region of Queensland.

Whereas in the past the Sunshine Coast was known for its tourism, retail sector and retirement living, we are now seeing a rapid growth in people wishing to make the area their permanent family home and to gain local employment. There is also the 2032 Olympics which will require enormous infrastructure projects throughout the south-east of the state with all the attending community, social and business opportunities.

During the year under review the Foundation received some \$46,000 in donations from a number of donors These donors can be offered tax deductibility due to the Foundation being a Deductible Gift Recipient. Our list of partners has increased with a list of new partners included in the Report of the Directors. Operational funding

was received from Sunshine Coast Regional Council for which the Foundation continues to be very appreciative. In 2022 a further three year funding agreement was finalised with the council. The Foundation developed and maintains the Gifted program which financially supports a number of local and highly talented artists drawn from a range of performance disciplines.

Due to being a Company Limited by Guarantee, the Foundation has no share capital and is dependent on annual surpluses and retained earnings to provide working capital. The 2022/23 financial result was a small surplus which is sufficient to support the Foundation in future years. As has been the policy in prior years, the Foundation holds meetings of directors every two months at which are tabled agendas, meeting discussion papers and

financial statements. These meetings are held at the University of the Sunshine Coast and we recognise this resource.

I thank fellow directors and Executive Officers of the Foundation for their support during the financial year just ended. Late in the 2022 calendar year we saw the retirement of the initial Executive Officer, Celestine Doyle. She provided great assistance to the Foundation and myself in the establishment of policies, systems, and processes.

# Gifted recipients

Sunshine Coast Arts Foundation's Gifted program supported nine diverse artist projects in 2023 including new ceramic, sculpture, watercolour, photographic, street art and dance artworks, a PhD mentorship, and a pilot film for a series of live music performances.

Seven of the projects were supported by Gifted Program Patrons, who nominated the arts medium or practice that inspires them as an investment into the recipient's creative journey. The event took place at the studio of local artist Tory Richards at Moffatt Beach on Friday, 11 November 2022.

Jane Anderson worked with a collaborative team of early-career Sunshine Coast artists to undertake The Dancer Project as part of a site-specific body of experimental work during a Project 24 residency at 2nd Space in Nambour.

Amanda Bennets – explored the medicalised body utilising installation, photography and video art for creative outcomes. Her art is influenced by the human body and medical encounters, exploring themes such as fragility, the self and death. She incorporates medical imagery and found footage to investigate the lived experience of the ill and medicalised body.

Michelle Bucci – Dancelab director and choreographer created Bound, a work exploring the concept of manipulation and restrictions with emerging artists Mia Polinelli, Taliah Collins and Jessica Jane Dick, all local Sunshine Coast artists who have studied dance abroad.

Mira Chorik – Mira Chorik is a performing artist and award-winning songwriter and producer based on Gubbi Gubbi land. Her work investigates loss and remembrance in performing art installations. She recently completed postgraduate study in Creative Arts and has a strong interest in art and music as the temple, experimental collaborations, and in hosting participatory group experiences.

**Finn Cossar** – Sculptor based on the Sunshine Coast works within the medium of stone and metal, allowing him to express creative concepts and powerful messages through the artform of sculpting. He challenges the observers of his artworks to consider how the sculptures coexist with their environments. He primarily utilises poised balance within his artworks which explore environmental and existential concepts.


Shannon Garson – Ceramic artist based in Maleny began her creative life as a painter and this is evident in the intricate drawings that move across the surface of her thrown porcelain vessels, she investigate the relationship between human activity and the infinite variety of striations, spots, and marks found in nature.

A large part of her practice is to show reverence for the natural world and to be able to translate its sacred living presence into painting form.

Andrea Kirwin – Nambour musician, created Peace Run Records and Peace Run TV; a filmed live music concert series where once a month high quality live video recordings of a local artist supporting a touring artist performing live and acoustic at Peace Run Records is filmed. Her aim is to share this love of live boutique concerts with high quality artists as the focus

# Report of the Directors

The directors of Sunshine Coast Arts Foundation Ltd ('the Foundation' or 'SCAF') present their report together with the financial report of the Foundation for the year from 1 July 2022 to 30 June 2023.

In accordance with section 300B of the Corporations Act 2001, the directors set out below certain information in respect of the objectives, strategies, principal activities and performance of the Foundation.

#### Short and long term objectives

The short and long term objectives of the Foundation are encapsulated in the Mission and Vision of the entity. The Mission is to promote the development and prosperity of the arts on the Sunshine Coast through fundraising and philanthropic investment. The Vision is to achieve an enlightened and enriched local community transformed by philanthropic investment in the arts.

#### The strategy for achieving these objectives

- 1. Build the profile of the Foundation as the regional organisation supporting creative expression through philanthropic investment.
- 2. Develop, diversify and consolidate income streams.
- 3. Establish collaborative partnerships with key stakeholders.
- 4. Establish effective governance processes and procedures and recruit and develop a succession plan.

#### **Principal Activities during the Year**

Principal activities in four strategic priority areas noted above were as follows -

#### **1. PROFILE OF THE FOUNDATION**

 Profile was enhanced by numerous marketing and communication activities including eNews, invitations, announcements, Facebook posts, website and media materials.

- Directors met with prospective donors and attended SCAF and other arts events
- Chair, Board Directors and Executive Officer held meetings with prospective donors, supporters and arts sector representatives.

#### 2. INCOME STREAMS

- Gifted Patrons Group established with inaugural gifts.
- An increase in donations received on previous financial year.
- Income received through partnerships with arts organisations to accept and manage donations for a fee.

#### 3. PARTNERSHIPS WITH STAKEHOLDERS

- Council approved further three-year funding for SCAF from the new Arts
- and Heritage Levy. Nine artists and organisations were recipients of Gifted contributions for projects in 2022-23.
- New partnerships were established with Maleny Arts Council, Sunshine Coast Creative Alliance, Rangebow Festival, DanceLab, Fiona Jopp Dance and LJ Projects to manage their donations.
- Events were held in collaboration with the Caloundra Regional Galley, Tory Richards Artist Studio, Horizon Festival and the University of the Sunshine Coast.
- · Partners who provided in-kind support were: Caloundra Regional Galley, University of the Sunshine Coast and Sunshine Coast Regional Council.
- Mentoring and support provided to various organisations.

- 4. GOVERNANCE
- Bi-monthly Board meetings and AGM held.
- CRM developed and completed for operational use in October 2022.
- · Board conducts an annual self assessment.
- Reports annually to Sunshine Coast Regional Council and ACNC.

#### How those activities achieved the objectives of the Foundation

The activities raised awareness of the Foundation and of the benefits of philanthropy, identifying and cultivating donors, facilitating and attracting donations, consolidating and creating new partnerships and distributing funds to support artists to make new work.

#### Means by which performance is measured

The measures of success 2020-23 have been developed in line with the four Strategic Priorities in the SCAF Strategic Plan for the initial three-year establishment phase and being as follows:

- · Increase in awareness of the Foundation, its objectives, projects and ways to donate
- Increase in revenue and cash reserves.
- Increase in partner delivery of Foundation objectives.
- Increase in donors to giving programs and projects.
- · Satisfaction levels of donors and partners.
- · Foundation registered as a charity with tax deductible status.
- Succession Plan and working subcommittees/task forces in place.

## Notes to Financial Statements for the Year Ended 30 June 2023

#### NOTE 1

#### Summary of significant accounting polices

#### a) Basis of preparation

These financial statements, in respect of Sunshine Coast Arts Foundation Ltd (the Foundation), are general purpose statements prepared for the year from 1 July 2022 to 30 June 2023. The statements comply with Australian Accounting Standards – reduced disclosures as issued by the Australian Accounting Standards Board and the requirements of the Corporations Act 2001. The Foundation is a not-for-profit entity for financial reporting purposes and complies with such Australian Accounting Standards as applicable to not-for-profit entities. In particular the Foundation has adopted AASB 1060 General Purpose Financial Statements – Simplified Disclosures for For-Profit and Not-for-Profit Entities, first issued in March 2020 and as amended, which allows Simplified Disclosures for certain types of entities referred to as Tier 2 entities. Entities applying AASB 1060 are required to in turn apply all recognition and measurement requirements in Australian Accounting Standards and apply AASB 1060 in relation to disclosure requirements only.

Comparative information in these financial statements reflects the audited 2021-22 financial statements.

The financial statements have been prepared under the historical cost convention and except for cash flow information, on an accruals basis. The financial statements relate to the individual entity as the Foundation does not control other entities. The level of rounding used in these financial statements is to the nearest dollar. The presentation currency of the Foundation is the Australian dollar.

No accounting pronouncements were early adopted in the 2022-23 financial statements nor were any new accounting standards applied for the first time in 2022-23. No voluntary changes in accounting policies occurred during the 2022-23 financial year.

The financial statements were authorised by the Directors on the date shown in the Declaration by Directors.

#### b) Nature of the Foundation

The Foundation is a public company limited by guarantee and is incorporated under the Corporations Act 2001 with its domicile in Australia. The address of its registered office is 22 Omrah Ave Caloundra QLD 4551. The parent entity of the Foundation for financial reporting purposes is Sunshine Coast Regional Council. A description of the nature of the operations and objectives of the Foundation and its principal activities is included in the accompanying Report of the Directors.

The Foundation is registered federally as a charity with the Australian Charities and Not for Profits Commission ('ACNC') and in Queensland under the Queensland Collections Act 1966. The registration with the ACNC requires the Foundation to comply with ACNC Regulation 2013 to the extent that this regulation is not inconsistent with Australian Accounting Standards.

As a company limited by guarantee, the Foundation has no share capital and cannot pay dividends. The liabilities of Members in any winding up is limited to \$10 per Member.

#### c) Taxation

The Foundation is exempt from income tax but is subject to Fringe Benefits Tax where applicable. From October 2020 the Foundation was registered for GST with the net amount of GST recoverable or payable shown as an asset or liability in the balance sheet. In October 2020 the Public Fund of the Foundation became registered as a Deductible Gift Recipient.

#### d) Key accounting estimates and judgements

There are no key accounting estimates and judgements exercised by the Directors in the preparation of these financial statements except for the amortisation and useful life of software referred to in Note 3.

#### e) Volunteer services

The Foundation has the benefit of volunteer services in the matters of legal, accounting and philanthropic advice. Board directors were purposefully recruited with these skills and experience. The value of these volunteer services provided to the Foundation cannot be reliably estimated.

#### f) donations, investment income and grants

Donations and investment income are recognised when received. Donations that are provided for a specified purpose are recorded in a restricted cash account (refer Note 2 Cash and Cash Equivalents). Unless a grant contains sufficiently specific performance obligations for the Foundation to transfer goods or services to a third party on the grantor's behalf, grant revenue is recognised upon receipt of the grant funding.

#### g) Financial instruments

The financial assets of the Foundation consisting of GST receivable are recognised in these financial statements at amortised cost. Similarly, liabilities being trade and other payables are at amortised cost. These assets and liabilities are short term in their realisation and are based in and denominated in Australian dollars. The receivables carry no undue credit risk.

The Foundation also has assets in the form of cash and cash equivalents which are held by a major Australian regional bank. Given the still, by historical standards, low current interest rates, there is no interest rate risk.

The Foundation ensures that it has sufficient cash to meet expected operational expenses. In this way liquidity risk is managed.

During the reporting periods covered by these financial statements the Foundation has not issued any compound financial instruments, entered into hedge accounting or held derivative financial instruments.

#### NOTE 5 Key management personnel and related parties

Directors serve in an honorary capacity, refer Note 1e, and receive therefore no director fees. Out of pocket expenses are however reimbursed. The remuneration of the Executive Officer of the Foundation is paid under a contract and not employment arrangement and includes no postemployment or other long term employee benefits.

The only related parties of the Foundation relate to operational funding and other amounts paid by Sunshine Coast Regional Council. These amounts are disclosed in the Statement of Profit or Loss and Other Comprehensive Income and in note 4.

#### NOTE 6

#### **Economic dependency and** going concern

The financial statements have been prepared on a going concern basis which contemplates continuity of normal business activities and the realisation of assets and the settlement of liabilities in the ordinary course of business. Currently the ability of the Foundation to continue its operations at current levels is dependent upon the ongoing financial support of Sunshine Coast Regional Council - refer note 7.

#### NOTE 7 **Contingent liabilities and** capital commitments

In relation to contingent liabilities, in August 2022 the Foundation entered into a further three-year funding agreement with Sunshine Coast Regional Council and for the financial years ending 2024 -25. This new agreement requires the Foundation to reimburse unused funds at the end of the Term. It is not possible to estimate at this time the amount of those unused funds, if any.

The Foundation had no capital commitments at the reporting date (2022 \$ 12,000).

#### Events after the reporting date

#### NOTE 9
