However, was not taken up by a prospective business operator in 2019. In July 2020, a new prospective business operator sought approval from council to operate a pedal bike hire business from this location as a Low-use / low-impact permit. This business operator is now seeking an opportunity to operate under a High-use / high-impact permit. Since issuing the Low-use / low-impact permit, there have been no reported issues associated with the business operating at this location.  Given the location was previously identified as a High-use / high-impact location and is successfully operating under a Low-use / low-impact permit with no reported issues, it is recommended that this activity and location be included in the 2022-2025 expression of interest process.
