

I hereby notify of my intention to move the following motion at the Ordinary Meeting to take place on Thursday 31 January 2019:

That Council authorise the Chief Executive Officer to

- (a) Develop a Regional Arts Infrastructure Framework (network plan) as outlined in Action 3.1.1 of the Sunshine Coast Arts Plan 2018-2038
- (b) Allocate a budget of up to \$120,000 to prepare the Framework for Council consideration prior to awarding contracts or allocation of budgets to any arts/cultural infrastructure for the Sunshine Coast Region
- (c) Request that the draft Framework be brought back to the August 2019 OM of Council for its consideration

COUNCILLOR COMMENT/NOTES

Councillors,

As you would be aware, we have an increasing range of arts, culture and heritage study projects in the pipeline, however, as yet, we do not have an overarching regional network plan that brings those separate projects together.

Having a regional network plan would provide the 'big picture' strategic clarity needed to fully inform our decision making.

Such a plan would examine emerging opportunities, community ideas and competitive destinations in order to make recommendations on the strategic sequences possible to the planning and delivery of our regions arts/cultural/heritage infrastructure (and I recommend libraries be included in this category).

This Notice of Motion (NoM), seeks council direction on bringing forward the development of the Regional Arts Infrastructure Framework project, as required by the Sunshine Coast Arts Plan unanimously endorsed by Council in August 2018.

The objective of bringing this piece of work forward is to enable council to support its decisions and improve its overall strategic approach to the prioritisation of arts and cultural facilities across the region.

The infrastructure framework would fully inform council to optimise the sequence, scope and return on investment in key strategic arts/cultural infrastructure.

Described as action 3.1.1 in the Arts Plan, the Regional Arts Infrastructure Framework would consider:

- Iconic architecture; its role and value proposition
- First nations requirements
- The mapping and value of strategic locations for arts and cultural hubs and precincts including appropriate co-location and integration opportunities and space requirements
- All Council endorsed strategies, plans and policies as they relate to arts and culture.

I believe we would all agree that having an overall plan to understand the scope, scale, value and distribution of a broad definition arts infrastructure network is absolutely critical to reach our goals as a region and of our recently endorsed regional 20 year arts plan.
