Notes on 2018/2019 Levy:

- The funding associated with the '10 year transitional phase out arrangement' (SM10/029) has been incorporated as an ongoing initiative within the Environmental Operational Management Theme. This initiative will be maintained at the 2013/14 allocation of \$1,683,204 and recognised as "Environmental Management Expenses' within this theme.
- Environment Levy Conservation Estate (Council managed component only) as at February 2018 is 1719ha. The budget allocated includes materials and services and salary/wages associated with any maintenance works. The Environment Levy maintenance program funding will be determined on an annual basis and will consider total size of estate being managed, average maintenance cost and Consumer Price Index (1.9%).
- 3 Funding associated with the pest management operational expenses will continue as a "core" component of the annual Environment Levy Program
