#### 1. Short title

The amendment instrument to which this explanatory memorandum relates is the *Sunshine Coast Planning Scheme 2014 (Planning Scheme Policy Amendment) No. [insert] – Planning Scheme Policy for Development Works.* 

## 2. Type of local planning instrument

The proposed amendment to the Planning Scheme Policy for Development Works constitutes a planning scheme policy amendment in accordance with Schedule 1 of the *Minister's Guidelines* and *Rules*.

3. Entity making the proposed Sunshine Coast Planning Scheme 2014 (Planning Scheme Policy Amendment) No. [insert] – Planning Scheme Policy for Development Works

The entity making the proposed *Sunshine Coast Planning Scheme 2014 (Planning Scheme Policy Amendment) No. [insert] – Planning Scheme Policy for Development Works* is the Sunshine Coast Regional Council.

The purpose of the proposed Sunshine Coast Planning Scheme 2014 (Planning Scheme Policy Amendment) No. [insert] – Planning Scheme Policy for Development Works is to:-

- update the standards, specifications and procedures to guide the design, construction and delivery of new development asset infrastructure and works, including roads, stormwater, landscaping and recreation infrastructure;
- (b) update references and guidelines in the planning scheme policy;
- (c) delete redundant water and sewer specifications;
- (d) include a new section for the delivery of local parks;
- (e) correct spelling and grammatical errors;
- (f) amend sections to improve legibility; and
- (g) make other consequential or administrative amendments.

## Background

Planning scheme policies support the implementation of the *Sunshine Coast Planning Scheme* 2014 (the Planning Scheme) by providing guidance and advice about how to satisfy the Planning Scheme's development requirements.

The purpose of the Planning Scheme Policy for Development Works is to provide:

- advice about achieving outcomes in the relevant Planning Scheme codes and
- guidance for the design and construction of infrastructure works which reflects sound practice in engineering, environmental management and natural resource planning and

sustainability, while also addressing considerations relating to whole of life cycle costs, safety, accessibility and aesthetics.

The Planning Scheme Policy for Development Works is a technical document that sets out Council's requirements across various infrastructure asset networks including roads, stormwater, landscaping and recreation, and defines standards and procedures for contributed assets with regard to construction, compliance and acceptance.

As a consequence, the Planning Scheme Policy for Development Works is mainly used by developers and their engineering consultants when designing and constructing development works and by Council's Development Services Branch when assessing and deciding development applications for operational work as well as subsequent compliance activities.

Having been in operation since the Planning Scheme took effect in May 2014, it is considered timely to review and, where appropriate, update the standards, specifications, inspection, testing and certification regime in the Planning Scheme Policy for Development Works to ensure ongoing relevance and consistency with up to date engineering practices and to improve the quality of contributed assets, particularly from a whole of life cycle cost perspective.

## Details of the proposed Sunshine Coast Planning Scheme 2014 (Planning Scheme Policy Amendment) No. [insert] – Planning Scheme Policy for Development Works

The proposed Sunshine Coast Planning Scheme 2014 (Planning Scheme Policy Amendment) No. [insert] — Planning Scheme Policy for Development Works generally relates to updating detailed construction specifications, updated terminology and to include desired standards of service for local parks, as detailed in Table 6.1 (Summary of Planning scheme policy for development works amendment).

## 9. Public consultation

Public consultation on the proposed planning scheme policy amendment was required to be undertaken for a minimum of 20 business days, in accordance with the *Minister's Guidelines and Rules*.

At the Ordinary Meeting held on 15 October 2020, Council decided to amend the Planning Scheme Policy for Development Works and to delegate authority to the Chief Executive Officer to prepare and progress the proposed amendment under the *Planning Act 2016* and the *Minister's Guidelines and Rules* (Council Resolution No. OM20/109).

In accordance with Council Resolution No. OM20/109, the proposed amendment was placed on formal public consultation from **Monday, 2 November to Friday, 4 December 2020** (inclusive). The consultation and communication strategy implemented during the public consultation period involved the following:-

- public notice published in the Courier Mail (including online in the Courier Mail and the Sunshine Coast Daily) on 31 October 2020;
- release of an industry newsflash
- copy of public notice and amendment documentation made available at all Council
  offices, libraries and on Council's website;
- dedicated webpage on Council's 'Have Your Say' webpage, including a copy of the public notice, amendment documentation and an online submission form;
- briefings to key stakeholder groups (including Organisation Sunshine Coast Association
  of Residents (OSCAR) and affiliates and the Urban Development Institute of Australia
  (UDIA)); and
- phone and email enquiries.

### 10. Consideration of submissions

In accordance with the *Minister's Guidelines and Rules*, following public consultation, Council must consider every properly made submission about the proposed planning scheme policy amendment, and may consider other submissions.

A total of 12 submissions were received in relation to the proposed planning scheme policy amendment. Of the total number of submissions received, 10 submissions outlined provisional or full support for the proposed planning scheme policy amendment and raised a range of concerns in relation to specific aspects of the proposed planning scheme amendment. 2 submissions raised matters which were considered to be outside the scope of the proposed planning scheme policy amendment.

A consultation report has been prepared, which provides a summary of the matters raised in submissions and how these matters have been dealt with (refer to **Appendix 1 – Consultation Report**). A copy of the consultation report will be provided to each person who made a submission and will also be made available to view or download on Council's website.

### 11. Background studies and reports

No background studies and reports have been prepared during the preparation of the proposed Sunshine Coast Planning Scheme 2014 (Planning Scheme Policy Amendment) No. [insert] – Planning Scheme Policy for Development Works.

The proposed desired standards of service for local parks have been derived from the Environment and Liveability Strategy 2017.
