### Background and Overview

Nominations are invited for membership of the Sunshine Coast Heritage Reference Group.

The Reference Group works to:

- raise the profile of cultural heritage in the region
- contribute to a shared vision for cultural heritage that is inclusive, relevant and innovative
- support the development of a regional network of individuals, organisations and museums in the heritage sector
- identify partners and opportunities to preserve, access and enhance cultural heritage across the region
- assist in forming strategic priorities for expenditure of the Sunshine Coast Cultural Heritage Levy

The Reference Group will consist of representatives of council, traditional cultural groups, heritage practitioners and architects, historical societies, museums, business, tourism and the wider community.

Portfolio Councillor Transport, the Arts and Heritage will chair the Sunshine Coast Cultural Heritage Reference Group.

### Membership

Interested individuals should have a demonstrated commitment to cultural heritage and an ability to contribute to the identification of needs and opportunities for the region's cultural heritage.

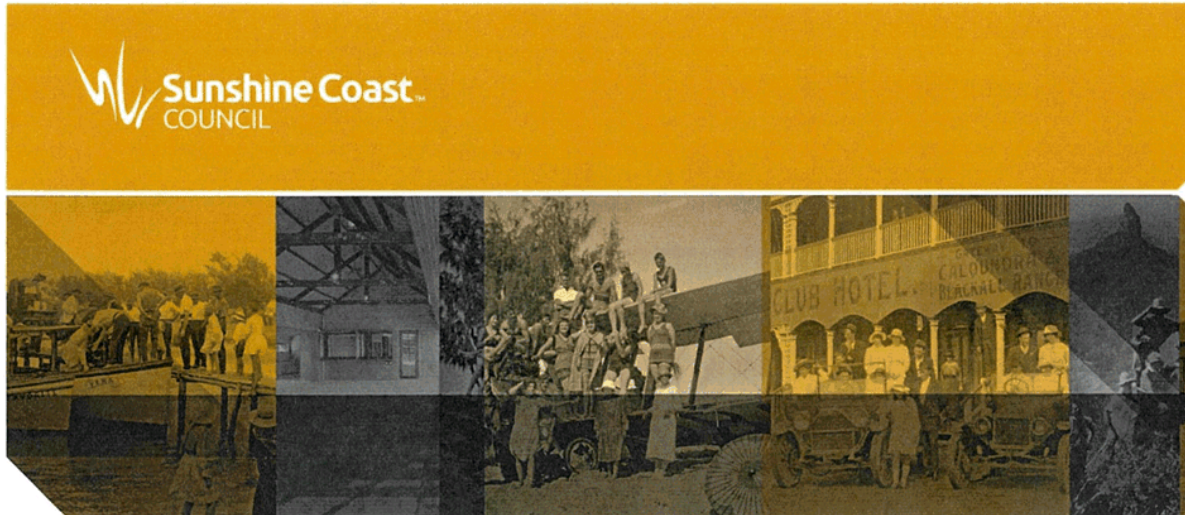
Experience in the heritage sector, business, tourism, creative industries or marketing would be well regarded.
