As required by s175E of the *Local Government Act 2009*, Councillor M Jamieson informed the meeting of a personal interest in matters that are the subject of Agenda Item 4.1 on the basis of the following:

As Mayor, I also hold the position of President of the Local Government Association of Queensland.

For nearly 50 years, it has been the practice that the President of the LGAQ is also nominated as an Employer representative Director of the trustee of LGIASuper, which is the superannuation fund for the majority of Queensland local government councillors and employees.

My position as an Employer representative Director of LGIASuper has been noted on my Sunshine Coast Council Register of Interests since I took up that role.

LGIASuper holds a 32% stake in the Sunshine Coast Airport through its asset manager, Palisade Investment Partners.

Based on legal advice which I have received, the unintended and unforeseen consequence for me of being nominated as an Employer representative Director of LGIASuper is that it may give rise to a material personal interest in relation to matters Council may consider in relation to the Sunshine Coast Airport.

On this basis, under section 175C (2) of the *Local Government Act 2009*, I am informing you I may have a personal interest in matters that are the subject of Agenda Item 4.1 on the basis that I am an Employer representative Director of LGIASuper, which may be advantaged or disadvantaged by any decision that Council may make on this matter relating to the Sunshine Coast Airport.

In line with the requirements of section 175C (2) of the *Local Government Act 2009*, I will leave the Chamber and not participate in the discussion or vote on this matter.
